    - a. Partnership Adopted Vision for the San Joaquin Valley
    - b. The San Joaquin Valley will be a cohesive region composed of unique communities and a diverse population that is supported by a vibrant economy built on competitive strengths and sufficient resources to provide

a high quality of life for all residents now and in the future. This vision can best be achieved through public-private collaboration integrating actions and investments into a coherent strategy that commits immediate and sustained leadership to accomplishing specific objectives that moves towards accomplishing long-term goals.

C. Strategic Growth Plan – Proposed by the Governor in January 2005, and adopted by the Legislature in May 2006, for November ballot and subsequently approved by the voters:

1. Education - \$10.4 billion in GO bonds to fund K-12 & Higher Education – Proposition 1D
2. Housing - \$2.85 billion in GO bonds for homeownership, rental, and permanent housing – Proposition 1C
3. Levee Repair & Flood Control - \$4.09 billion in GO bonds to repair and maintain levees and improve flood control systems – Proposition 1E
4. Transportation - \$19.9 billion in GO bonds to fund repairs, reduce congestion, improve bridge safety, expand public transit and improve port security – Proposition 1B

D. Regional Blueprint Planning Grants awarded for Fiscal Years 2005-06 and 2006-07.

1. San Joaquin Valley Received \$2,000,000 of the \$5,000,000 awarded for 2005-06 – Merced County Association of Governments, Council of Fresno County Governments, Kern Council of Governments, Kings County Association of Governments, Madera County Transportation Commission, San Joaquin Council of Governments, Stanislaus Council of Governments, Tulare County Association of Governments.
2. San Joaquin Valley received \$1,950,000 awarded for 2006-07.
