# 2. Approve Agenda

#### 3. Coordinated Human Services Transportation Plan – Update

Mr. Snoddy introduced Heather Menninger and Dennis Brooks of AMMA Consulting to update the SSTAC member about the Coordinated Human Services Transportation Plan update. Ms. Menninger provided a PowerPoint presentation regarding the information she and Mr. Brooks have compiled as of the meeting date. There was a lengthy discussion on public transportation services types and public needs for those services county-wide. After the discussion, Ms. Menninger gave her remaining public outreach schedule for local social service agencies and stakeholders.

#### 4. Federal Transit Administration Section 5310/5316/5317 Grant Programs

Mr. Snoddy advised the SSTAC members that Kern COG staff was aware of only one FTA Section 5317 (New Freedom) grant application by the County of Kern's Regional Transit. Kern Regional applied for a three-year operational assistance grant to help fund an extension of its Lake Isabella service to Ridgecrest via Walker Pass. Mr. Snoddy also informed the members that three Kern County agencies had applied for approximately \$800,000 of FTA Section 5310. Those agencies included Bakersfield ARC, North of the River Recreation and Park District (NOR), and Desert Area Resource and Training (DART).

### 5. Unmet Transit Needs Process

Mr. Snoddy provided those attending members a copy of this year's Kern COG Unmet Transit Needs staff report with supporting public hearing documents from those agencies funded by Transportation Development Act (TDA) funds. Mr. Snoddy reported that a hard-copy of the report will be mailed to every SSTAC member who was unable to attend this meeting in-person. Ms. Wilbanks advised the members that Kern Regional Transit's unmet transit needs public hearing will be held on June 11, 2013. She will release the public hearing documents via E-mail to the SSTAC members as soon as she can receive approval. With the Kern Regional Transit documents, the SSTAC members will be scheduled to make a county-wide unmet transit needs determination on Wednesday, June 12, 2013.

# 6. Crosswalk Discussion

Mr. Snoddy reported to the members that he had E-mailed Ryan Starbuck from the City of Bakersfield Public Works Department regarding the member's interest in improving the crosswalk safety at 22<sup>nd</sup> Avenue and Chester Avenue. Mr. Snoddy reported that at this time, he had not received a response but he will continue his efforts and report back at the next meeting in June.

#### 5. Crosswalk Discussion

Mr. Snoddy referred to the previous discussion held by the SSTAC regarding the crosswalk at 22<sup>nd</sup> Street and Chester. Mr. Snoddy explained that the intersection is a very dangerous intersection and that he had asked Susanne Campbell of Kern COG to look into some possible resolutions to make the crosswalk safer.

Ms. Campbell addressed the committee. She stated that she had spoken with John Ussery who is an Engineer with the City of Bakersfield regarding the intersection. Ms. Campbell shared that Mr. Ussery stated they have looked into improvements. However, at this time, there are no improvements that can be made. The City will continue to look into ways to make the intersection safer. In the meantime, they will keep the shrubbery cut back so that the crosswalk remains very visible. Ms. Campbell noted that the City of Bakersfield is open to suggestions for improving safety at that intersection.

Mr. Rendes stated that controlling the landscaping will benefit the visibility at the crosswalk.

#### 3. Transportation Development Act Revision

# 4. Triennial Performance Audits - Update

Mr. Snoddy advised that he had mailed out draft forms of the Triennial Performance audits to each member agency. At that time Mr. Snoddy requested that each agency send a response to Derek Wong at PMC and copy Mr. Snoddy by June 14th.

# 5. Transit Development Plan - Kern River Valley

Mr. Snoddy stated that they received two Transportation Development Grant applications. One application was for Mojave and one for the Kern River Valley, they are both under the operation of Kern Regional Transit. Mr. Snoddy advised that Caltrans stated the Mojave application was not strong enough to be considered. The Kern River Valley project was accepted by Caltrans District 9.

# 6. Transit Operators Forum

- Mr. Snoddy stated that Kern COG has received a notice from Caltrans PTMISEA that they will be receiving approximately seven million dollars towards previously applied for projects. Mr. Snoddy gave a brief overview of what projects will receive the funds.
- Mr. Snoddy advised that there was a call for projects at the June TTAC meeting for reprogramed PTMISEA funds.
- Ms. Scherr stated that 5311 program should be online next year. That will allow operators to submit their applications online rather than paper copies.
