Mr. Troy Hightower with Kern Transportation Foundation addressed the committee stating KTF had their first major conference on May 1st, 2019 for logistics and distribution. It was well attended and a lot of staff from Kern COG attending for which he expressed appreciation. It is planned to be an annual event and he encouraged everyone in the future to attend.

Ray Scott from Price Disposal addressed the committee and stated in February they wrapped up their K-12 Statewide Recycling Challenge. They have grown from 45 schools to 493 schools.

V. KERN RIVER BIKEPATH EXTENSION PROJECT UPDATE

The County of Kern was awarded an Active Transportation Program grant to design and construct an extension of the Kern River Bikepath from the bikepath's current end at Highway 43 and the Kern River to the Buena Vista Recreation Area. A staff member of the lead agency, the Kern County Public Works Department, Yolanda Alacantar, outlined the project's current status and a timeline for the completion of the project.

Ms. Alcantar provided the committee the following update:

- o Approximately \$3 million in funds were granted in FFY '18-19
- o In June of last year a 1 year extension was granted
- o Other funds total \$950,000
- o 4.5 miles in length (a map was provided)

There have been difficulties, and since initiation the county has evaluated 14 other route alternatives. Problems range from exposing the public to hazardous operations and/or materials, to bridge modernization requirements from Caltrans, adding potentially millions of dollars to the project, to significant parts of the project being in Caltrans right-of-way under the I5 and SR43, which is a very lengthy oversight permit process. The most significant difficulty has been the path going through the Kern water bank property, 17,000 acres is water-bank recharging, so they are very sensitive to this project as there are also 43 protected special status species. This has required 3 years of biological surveys, protocol level surveys, which have been costly. Just the biology portion of this project will be under \$320,000. Environmental clearance was finally issued last week by Caltrans to complete the environmental phase of this project. Design is 60% complete, pending final right-of-way alignment. Several permits are going to be required including Army Corp of Engineers, Regional Water Quality Control Board, encroachment permits with Caltrans and the city of Bakersfield, among others. It will be taken to CTC January 2020, bids will start Spring 2020 and construction in Summer 2020 with a 90 working day(s) schedule.

Supervisor Couch thanked Ms. Alcantar for her hard work with this project. He had other questions, some for Mr. Hakimi, which were answered.

VII. CALTRANS' REPORT: (Report on Projects in Progress)

Famoso SR 46/99 Bridge:

Bridge replacement at the SR 46/99 Separation.

Median barrier being installed along State route 99. Completing the slopes for hydroseeding. Performing punch list items. Waiting for Rail Road flaggers to complete the pavement, Dike placement final striping and signs.

SR 99 Taft Highway 2R Rehab: Pavement rehabilitation on SR 99 near the City of Bakersfield from north of the Herring Road overcrossing to the Pacheco Road undercrossing. All construction work done.

Route 46 Conventional Highway Segment 4A: Widen SR 46 from a 2-lane to a 4-lane conventional highway between Lost Hills Rd and I-5.

Constructing western transition this week, and eastern transition will be constructed next week under one-way traffic control at Ker-46. Ramp-4 was scheduled to be constructed this week. It is anticipated that construction will be completed by June 15, 2019.

Lane closure schedule: Ker-46 One-way traffic closure this week and next week. Ker-5-NB on-ramp 55-hour closure expected the week. Ker-5- Lane closure and Full closure during false work release and removal next four weeks.

SR 99 Rehab: Pavement rehabilitation on SR 99 in Kern County from 0.3 mile south of Palm Ave OC to Beardsley Canal Bridge and on Route 178 at Route 99/178 Separation.

Work currently scheduled for the next 30 days (subject to change due to weather, equipment / labor availability):

- SB Median work from just south of Palm Ave OC to just north of SR 204 OC
- Possible panel replacements in lane 1 from Olive drive to Beardsley canal

Traffic control related update(s):

- Extended lane closures these closures are currently in place and will not be reopened to traffic until 2021:
- o Lane No. 1 NB has been closed from SR 58 OC to just north of SR 204 OC
- Lane No. 1 SB has been closed from Beardsley Canal to just south of Palm Avenue OC.
- Nightly closures of adjacent lanes may be needed weekly from Sunday to Thursday to complete the work from Palm Ave OC to Beardsley Canal. Only one closure will be permitted per direction
- Ramp closures are currently not anticipated

Cottonwood East Rehab: Pavement rehabilitation (2R) on SR 58 in Bakersfield from the Cottonwood Road undercrossing to just east of the SR 58/184 separation.

The contractor is continuing to pour CRCP in the EB Direction #3 lane and shoulder (Including the SR184 and Fairfax ramps) between Fairfax and SR184. The WB has been excavated between SR 184 and Oswell. The current end date for working days has been pushed out to July 17th.

Cache Creek Bridge Replacement: Replace bridge on SR 58 8 miles east of Tehachapi, from the Sand Canyon overhead to 0.5 miles east of Cache Creek.

Contractor is working on installing K-rail and reconstructing the outside shoulder, and demolition of EB bridge will on second week of June 2019.

Summit OH Bridge Rails: Replace Bridge Rails on SR 58 near Tehachapi at Summit Overhead.

The pre-construction meeting was held on 2/12/19. Start of construction was moved to May 27, 2019 due to coordination with UPR.

Lerdo Canal Median Gap Closure: Median deck closure near Bakersfield at the Lerdo Canal on SR 99. The project will be delayed until September 9, 2019 due to nesting birds.

I-5/99 Bridge Separation and Pavement rehabilitation on SR 99 I-5/SR 99 junction to the Panama Lane overcrossing. (Old US 99 Overcrossing)

The project will rehab the NB outside lanes and shoulder from 5/99 split to Old US 99 with CRCP, and will improve bridge vertical clearance under the 99/5 Separation Bridge in both directions.

Construction started 4-22-19. Work taking place at SB median under I5/SR99 bridge. NB shoulder work from Copus Rd to Union Ave.

Stockdale/Enos Roundabout: Construct Roundabout at SR 43 and Stockdale Highway. Start of construction in spring 2019.

119/43 Intersection Improvements: Construct a roundabout at intersection of SR 119/43.

- Construction started beginning of May.
- Environmental trapping has been done.
- Wild life fencing installed.
- Detour work is taking place.
