Enclosed for your review and approval is Amendment No. 5 to the 2019 Federal Transportation Improvement Program (FTIP). Amendment No. 5 to the 2019 FTIP contains project phases and/or projects that meet all applicable transportation planning requirements per 23 CFR Part 450 and 40 CFR Part 93. The proposed project changes have been determined to be exempt from the requirement that a conformity determination and/or regional emissions analysis be performed per 40 CFR 93.126, 93.127, or 93.128.

A 14-day public review and interagency consultation period was completed on July 19, 2019. A public hearing was held on July 18, 2019. No comments were received at the hearing. Corrections were made to the amendment documentation as included in the summary of comments. The public participation process for Amendment No. 5 to the 2019 FTIP is consistent with Kern COG Board adopted public participation plan. With this letter, the Kern COG Executive Director approves Amendment No. 5 to the 2019 FTIP. State and Federal approval is required.

## **2019 Federal Transportation Improvement Program Amendment No. 5 Summary of Comments and Responses**

As part of the development of the 2019 Federal Transportation Improvement Program Amendment No. 5, stakeholders, technical staff, and the general public were given the opportunity to comment. The public review period was held July 5, 2019 to July 19, 2019.

### **State Department of Transportation (Caltrans)**

Office of Federal Transportation Management Program (OFTMP) – email dated 7/8/19

1. Attachment 3 is missing information on KCOG's PM2 and PM3 performance measures. KCOG's 2019 FTIP adopted on 8/16/18 only contained Safety Performance Measures (PM 1) – please see pages 19 and 20. Subsequent approved amendments from KCOG have not indicated any PM 2 or PM 3 performance measures (targets). Attachment 3 is incomplete as there is no mention of KCOG's Pavement and Bridge Conditions (PM 2) Performance Measures (Targets) and there is no mention of KCOG's System Performance (Travel Time Reliability), Freight, and Air Quality (PM 3) Performance Measures (Targets). Please see the 4/16/19 CFPG Meeting Minutes that were sent out to all MPOs and specifically Item 8: FHWA indicated at that meeting that all MPOs need to provide language that PM2 and PM3 targets are being worked on and that this PM2 and PM3 language is required to be in any amendments on or after 5/20/19. KCOG's PM 2 and the PM 3 targets need to be indicated in KCOG's FTIP via Amendment No 5. Attachment 3 is incomplete as it only indicate progress towards achieving PM2 and PM 3 targets without indicating what the PM 2 or PM 3 targets are. Please revise Attachment 3 to comply with FHWA's direction.

**Response:** Revision was incorporated into the final document – Attachment 3.

SHOPP Coordinator – email dated 7/8/19

1. At the June CTC meeting the Commission amended the SHOPP to include a new Collision Reduction project (0X760) and an increase to an existing project (0V280). The SHOPP group listing was updated to include these changes.

### **Performance Measures**

## **Kern COG 2019 FTIP Performance Measures**

The 2012 federal transportation authorization legislation, ‘Moving Ahead for Progress in the 21st Century’ (MAP-21) established new requirements for performance management and reporting to ensure the most efficient investment of Federal transportation funds. To incorporate the new federal performance requirements for Safety (PM1); Pavement and Bridge Conditions (PM2); and System Performance (Travel Time Reliability), Freight, and Air Quality (PM3) into the Federal Transportation Improvement Program (FTIP), Kern Council of Governments is required to show (1) that the FTIP “makes progress towards achieving the Kern region’s performance targets”, and (2) that the FTIP includes, “to the maximum extent practicable, a description of the anticipated effect of the FTIP towards achieving the performance targets.”

The projects contained within the 2019 FTIP, as amended, have been developed in accordance with the applicable provisions and requirements of 23 CFR Part 450 and are expected to support the achievement of these targets. These targets will be achieved through the implementation of investment priorities through the programming of transportation projects in the 2019 FTIP, this FTIP Amendment, and subsequent FTIP Amendments and Administrative Modifications.

## **Safety Performance Measures (PM1)**

The Kern COG Board voted on February 15, 2018 to approve the Kern PM 1 targets. Kern COG provided the description below (in the 2019 FTIP) on how investment in the FTIP will contribute toward achieving the PM 1 targets for Safety.

Kern COG has adopted five new safety performance measures developed consistent with the state targets and the federal methodology as required by MAP-21 and FAST ACT. The recommended targets for 2018 (5-yr) are as follow:

- Number of fatalities: 148
- Rate of fatalities per 100 million VMT: 1.63
- Number of serious injuries: 329
- Rate of serious injuries per 100 million VMT: 3.63
- Number of non-motorized fatalities and non-motorized serious injuries (bicycles and pedestrians): 98

The methodology uses California Highway Patrol (CHP) historical accident data (SWITRS) for Kern County and a 5 year running average to forecast future accidents. Kern COG's member agencies are encouraged to promote projects and policies that will help the region to perform better than the national targets for the Kern region. In an effort to encourage projects funded with federal dollars to address safety concerns, Kern COG has implemented ranking criteria that prioritizes projects that have a safety component, which accounts for as much as 25% of the total score for regional projects.

In addition Kern COG strives to improve communication and coordination between public agencies and the public by identifying and engaging key transportation planning stakeholders. Through the stakeholder groups, Kern COG often identifies safety issues critical to their interests. For example, Kern COG works closely with member agencies (cities and county) and Caltrans in nominating projects for the State Highway Operation and Protection Program, Highway Safety Improvement Program, and Active Transportation Program.

Projects listed in Amendment No. 5 that would demonstrate progress towards achieving the performance measures outlined in the 2019 FTIP:

- Active Transportation Program Cycle 3 – KER161008
  - This project seeks to improve the safety for pedestrians by constructing a pedestrian path.
- Active Transportation Program Cycle 4 – KER191004
  - This project seeks to improve the safety for cyclists by constructing a Class 1 multi-use path.
- State Highway Operations and Protection Program – KER180202
  - This project seeks to improve safety by constructing a roundabout.



## **Pavement and Bridge Conditions (PM 2)**

The Kern COG Board voted on September 20, 2018 to approve the Kern PM 2 targets consistent with the state targets. The PM2 targets are contained in the following table.
