V. CMAQ FUNDING REQUEST

Kern COG staff seeks Transportation Technical Advisory Committee direction on which option to forward to the Transportation Planning Policy Committee. The options are:

Option 1: Fund Tehachapi's request; Option 2: Fund Wasco's request; Option 3: Allow for a Kern County project swap thereby funding both the Tehachapi and Wasco requests; Option 4: Do nothing.

Ms. Viterelli made the motion to recommend Option 3. Mr. Topete seconded the motion. Ms. Invina-Jayasiri performed a roll call vote and motion carried unanimously.

VI. REGIONAL EARLY ACTION PLANNING 2.0 GRANT FUNDING

Comment: Ms. Napier stated that two workshops were conducted, Wednesday September 28, and Wednesday, October 12, 2022. During both workshops, each Agency was allotted time to present their project and answer questions. Ms. Napier reviewed the Grant Timeline and Workshop Results. The results of the Survey conducted to rank the projects is as follows (with [1] being the most desirable project):

Ms. Napier then reviewed the comments submitted by participants:

I would like to take this opportunity to reiterate our concern, as also pointed out by other agencies, with Arvin's project and their ability to deliver their project within the parameters and deadlines established with the funding requirements of REAP 2.0. I don't mean to say that their staff is not capable of delivering projects, it is rather the timeline of their permits, other funding process and delivery of their project in less than 2 years.

I would like for the top 5 projects to be submitted with the full \$17mil request. However, in order to fit the \$12.6mil budget, I only recommend the top 4 projects submitted with adjustments on both housing projects from Arvin and Bakersfield. I would recommend to fully fund Shafter and Wasco's projects... subtract Arvin's \$1.2mil for the transportation hub bringing their request down to \$6.1mil... then give the remaining \$5,590,482 to the Bakersfield Senior Center Project, more specifically for the larger mixed use development.

I have included ranking for projects with adjusted dollar amounts to meet the \$12,670,717 allocation and without adjusted amounts totaling the full \$17,280,235 ask. Adjustments:

City of Arvin \$5,000,000 (Leveraged funds \$4,000,000; Water, Sewer, Power

\$1,000,000)

City of Bakersfield BSC \$6,690,483

City of Bakersfield Bike Path \$0

 City of Shafter
 \$230,234.59

 City of Wasco
 \$750,000

Total Funding \$12,670,717.59

My take on asking for more money than our allotment is that it is potentially risky since our project list does not lend itself to just dropping the bottom project to fit within the \$12 million allocation. In that case, we would end up having to figure out what to cut and how to cut it anyway if the State doesn't have additional funds available or if they come up with some alternate method of disbursing additional funds.

Ms. Napier also discussed a webinar that she participated in on Tuesday, November 1, with CALCOG and other California MPOs. She stated that everyone is concerned about the timeline for the grant and the ability of HCD to respond in a timely manner to the December application process and provide timely agreements to the applicants to meet the very tight timeline. The meeting was then turned over to Chairman Schlosser.

Chairman Schlosser asked if there were any comments from the audience. One comment was received virtually from Troy Hightower. Chairman Schlosser then asked if any TTAC or RPAC members had questions. Each applicant was asked a series of questions concerning their projects (generally the questions were the same to each applicant). After the questioning was complete, Chairman Schlosser asked if there was a suggestion on how to proceed. RPAC Chairman Staples stated that he was ready to make a motion. After final questions from Committee Members, the following action was taken:

Action: RPAC Chairman Staples made a motion to recommend to the Kern COG Board to submit an application in the amount of \$12,670,717 for the following project and amounts:

\$750,000 Wasco Alley Rehabilitation for ADUs

\$230,235 Shafter Tract 6713

\$6,000,000 Bakersfield Senior Center Affordable Senior Housing & Facility

\$5,690,482 Arvin "Keeping it Green in the San Joaquin"

and create a contingency list with the application to include:

\$3,000,000 Bakersfield Hageman Bike Path \$1,609,518 Remained of Arvin Project

Motion seconded by Committee Member Esselman with a unanimous roll call vote.

DESCRIPTION:

The California Transportation Commission (CTC) closed the statewide Cycle 6 Active Transportation Program (ATP) Call for Projects on June 16, 2022. Kern COG agencies submitted a total of 19 applications.

DISCUSSION:

At their March 16-17, 2022, meeting, the CTC adopted the 2022 ATP Cycle 6 Fund Estimate and program Guidelines. With the adoption of the Guidelines, the Cycle 6 Active Transportation Program call for projects was subsequently initiated. The CTC adopted their selected statewide applications at the December 7-8, 2022, meeting. One Kern region project was included in the statewide project adoption, which is the County of Kern Norris Pedestrian and Railroad Safety project totaling \$9.8 million. All remaining Kern COG applications are now reviewed for funding with the MPO share of the Cycle 6 ATP funding. The proposed MPO list is found on page 3 of this report. It reflects the adopted regional ATP policy. The updated timeline below provides a reminder of what's next for this ATP Cycle 6 call for projects.

Cycle 6 ATP TTAC Page 2 January 4, 2023

Background: At the August 18, 2022, California Transportation Commission (CTC) meeting, the Commission adopted a revised Fund Estimate for the Active Transportation Program (ATP) Cycle 6, which is now adopted. The approved revised Fund Estimate for the statewide ATP budget is now **\$1.7 billion** due to an infusion of funding from the recently approved 2022-23 state budget. The Kern COG guaranteed regional share of that statewide has been increased to **\$16.798 million**. During the August CTC meeting, presenters noted several things:

- 1) the total number of applications for Cycle 6 was over \$3 billion;
- 2) the CTC hopes that a good ATP delivery record will encourage future legislated ATP add-on funds;
- 3) the full amount is available in the first year but projects will be programmed over a 4-year period; and
- 4) the CTC will support early allocation requests for delivery of the Cycle 6 projects.

Original Fund Estimate –The statewide budget for the 2022 ATP Cycle 6 Call for Projects for the 4-year span for this cycle, 2023-24 through 2026-27, is \$1.7 billion. Now that the staff recommendation has been published, Kern COG will evaluate and consider funding those applications in the order that they were ranked by the state. The original Kern COG's MPO target funding amount for Cycle 6 for the 4-year span from 2023-24 through 2026-28, is \$16.8 million. Kern COG staff will develop an MPO list in January 2023 and circulate it to the TTAC. In February, staff will provide a TTAC item with the recommended final MPO list for regional adoption in February 2023. The MPO recommendation will be sent to the CTC for adoption of MPO selected projects by June 2023.

Kern COG Policy Background - CTC ATP Guidelines and Fund Estimate establish the project selection process and ATP programming capacity for the state and MPO share. When ATP first began, the Kern Council of Governments adopted its ATP project delivery policy that defers to the original state application review and ranking for all original state submitted applications. Kern COG does not do a separate ATP Call for Projects to use the MPO share and therefore does not adopt its own modified guidelines or conduct a separate MPO call for projects. Instead, Kern COG considers the remaining applications for MPO share funding following the ranking order as best as possible already established by the state-ranked applications not selected by the state. Submitted applications from Kern agencies - The ATP Cycle 6 statewide call for projects resulted in 19 Kern region submitted applications for a value of **\$69 million**. They are listed on page 3. This table has been updated to include the ranking values for each application. The County of Kern project that ranked 91 is highlighted in yellow. This project has been approved for state funding. Projects recommended for the MPO list are highlighted in blue. This selection is based on Kern COG policy and has been financially constrained to the CTC adopted ATP Cycle 6 Fund Estimate. Kern COG's revised share is estimated at \$16,798,000 over a 4-year programming cycle from 2023-24 through 2026-27. Kern COG staff recommends that the remaining \$133,000 be added to the Kern River Parkway Multi-Use Safety and Connectivity project to offset part of the local funding. This item is for information and will be presented in February as an action item.

CALL FOR PROJECTS

DESCRIPTION:
