**VII. FY 2022-23 KERN REGION ESTIMATED LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) CALL FOR PROJECTS \$2,369,913 (Enriquez)**

**Comment:** Annual Caltrans funding is available for transit expansion projects that reduce greenhouse gas emissions for a very limited time through Low Carbon Transit Operations Program (LCTOP). The region is estimated to receive a total of \$2,369,913. Member agencies eligible for LCTOP funds were e-mailed the regional apportionment Wednesday, March 15, 2023.

**III. APPROVAL OF DISCUSSION SUMMARY:** Minutes from meeting of February 1, 2023

There were no comments or questions from the committee members. Mr. Reed made a motion to approve the discussion summary, Mr. Topete seconded the motion. Ms. Invina-Jayasiri performed a roll call vote and motion carried unanimously.

**IV. CYCLE 6 ACTIVE TRANSPORTATION PROGRAM – MPO PROJECT LIST**

Mr. Snoddy stated the ATP Cycle 6 statewide call for projects resulted in 19 Kern region submitted applications for value of \$69 million. Mr. Snoddy and Mr. Stramaglia also stated staff is preparing an MPO final submittal package of information as prescribed by the CTC. It is possible that the CTC may adopt the Kern projects prior to the scheduled adoption date in June.

**V. KERN AREA REGIONAL GOODS-MOVEMENT (KARGO) SUSTAINABILITY STUDY UPDATE**

Mr. Davisson reported the Phase II KARGO Sustainability Study, a project looking to address the needs and impacts of increased freight movement in the region, is requesting local jurisdictions review and verify current development impact fee rates in the attached report. The intent of the KARGO2 study is to work with community stakeholders including the City of Shafter, City of Bakersfield, Kern County, Caltrans, and railroads to evaluate strategies to improve the sustainability of growing regional goods movement activity in Kern County and impacts on the transportation system and surrounding communities including disadvantaged communities.

**VI. CMAQ FUNDING REVISION REQUEST**

Ms. Pacheco reported there is a request for a revision to an existing Congestion Mitigation Air Quality (CMAQ) Program project. Kern COG staff has reviewed options for the CMAQ funding available. On February 16, 2023, the City of Taft staff met with Kern COG staff to discuss the options for delivery of the CMAQ project. Kern COG staff seeks Transportation Technical Advisory Committee direction on which option to forward to the Transportation Planning Policy Committee.

**Option 1:** Select Taft to receive \$2,956,140 in CMAQ funding for only the infrastructure component. **Option 2:** Select Taft to receive \$1,379,254 in CMAQ funding for only the vehicle purchase component. **Option 3:** Do nothing.

Kern COG staff recommends Option 1.

The action requested is that the Transportation Technical Advisory Committee recommend Option 1 to the Transportation Planning Policy Committee. The City of Taft recommends Option 1.

Ms. Viterelli made a motion to approve the recommendation, Ms. Kolosky seconded the motion. Ms. Invina-Jayasiri performed a roll call vote and motion carried unanimously.

It was noted that there is now funding available for underfunded CMAQ projects. Kern COG staff will review project funding requests and prepare a staff report for April.

**VII. 2024 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM**

Ms. Pacheco reminded this is the monthly update on the activity related to the 2024 Regional Transportation Improvement Program. The new addition is Appendix C which is the Save the Dates memo for upcoming workshops. There are four dates: April 26, June 21, August 23, and September 13 (tentative).

**VIII. FEDERAL TRANSPORTATION IMPROVEMENT PROGRAM (FTIP) AMENDMENT – TIMELINE**

Ms. Pacheco stated the upcoming amendment to the 2023 FTIP will include revisions to the State Highway / Regional Choice Program, Congestion Mitigation Air Quality Program, Transit Program, and Non-Motorized Program. The amendment documentation will be emailed to the TTAC when the public review period begins March 3rd.

**IX. REGIONAL SURFACE TRANSPORTATION PROGRAM (RSTP) – DRAFT TIMELINE AND FUND ESTIMATE**

Ms. Pacheco announced Kern COG staff developed a draft timeline and fund estimate to facilitate programming new Regional Surface Transportation Program projects. After approval by the Transportation Planning Policy Committee on March 16th, the draft timeline will be used for the upcoming Regional Surface Transportation Program call for projects cycle.

The action requested is that the Transportation Technical Advisory Committee recommend approval of the RSTP Timeline and Fund Estimate to the Transportation Planning Policy Committee.

Ms. Topete made a motion to recommend approval, Ms. Kolosky seconded the motion. Ms. Invina-Jayasiri performed a roll call vote and motion carried unanimously.

**X. CONGESTION MITIGATION AND AIR QUALITY (CMAQ) PROGRAM – DRAFT TIMELINE AND FUNDING TARGETS**

Ms. Pacheco stated Kern COG staff developed a draft timeline and funding targets to facilitate programming new Congestion Mitigation and Air Quality projects. After approval by the Transportation Planning Policy Committee on March 16th, the draft timeline will be used for the upcoming Congestion Mitigation and Air Quality call for projects cycle.

This year's call for projects cycle will also include Carbon Reduction Program or CRP funding. Staff recommends moving forward with programming the CRP funding following the CMAQ Policy and Procedure project selection process. The latest update is that the state has developed a Carbon Reduction Strategy with three pillars: 1. rail and transit, 2. bike and pedestrian, 3. BEV. BEV still needs to be clarified as Battery Electric Vehicle or possibly ZEV or Zero Emission Vehicle. This information is expected to be posted to the Caltrans CRP website in the next couple weeks. All pillars are eligible activities under the CMAQ Policy and Procedure.

The action requested is that the Transportation Technical Advisory Committee recommend approval of the CMAQ Timeline and Funding Targets to the Transportation Planning Policy Committee.

Ms. Viterelli made motion to recommend approval, Mr. Reed seconded the motion. Ms. Invina-Jayasiri performed a roll call vote and motion carried unanimously.

**XI. DISCUSSION ON TELECONFERENCING OPTIONS FOR VOTING MEMBERS**

Ms. Invina-Jayasiri reported during their February 16, 2023 Kern COG Board meeting, the Board members reviewed the options and made a decision to revert back to the "classic" Brown Act rules on teleconferencing. She reviewed the Section 54953(b)(3) teleconferencing rules. In addition, the Board Members stated all Kern COG committees and subcommittees will follow the same teleconferencing requirements as listed above, and teleconferencing options will continue to be

made available for Kern COG staff and public. If committee members choose to teleconference for a committee meeting, their location must be posted on the Agenda in advance; otherwise, their vote will not be counted for that meeting. Provide staff 10-day advance notice of attending remotely.

Ms. Invina-Jayasiri offered that she will email in advance requesting members who decide to telecommute and will add the meeting location to the agenda.

**XII. FY 2022-23 KERN REGION ESTIMATED LOW CARBON TRANSIT OPERATORS PROGRAM (LCTOP) CALL FOR PROJECTS**

Ms. Enriquez stated Kern COG staff will receive an apportionment estimate from Caltrans staff for the Kern Region for the Low Carbon Transit Operations Program (LCTOP). The 2022-23 SCO Program of Projects will be presented to TTAC members once the SCO has released final apportionment funds. Presentation and adoption of the Kern COG FY 2022-23 LCTOP POP and submittal of the member agencies allocation request by March 3, 2023 to staff.

All FY 2022-23 LCTOP completed project applications (with supporting documents) are due to Caltrans LCTOP staff before March 24, 2023.

**DESCRIPTION:** The California Transportation Commission (CTC) closed the statewide Cycle 6 Active Transportation Program (ATP) Call for Projects on June 16, 2022. Kern COG agencies submitted a total of 19 applications.

**DISCUSSION:** The CTC adopted the 2022 ATP Cycle 6 Fund Estimate and program Guidelines at their March 16-17, 2022, meeting. With the adoption of the Guidelines, the Cycle 6 Active Transportation Program call for projects was subsequently initiated. The CTC adopted their selected statewide applications at the December 7-8, 2022, meeting. One Kern region project was included in the statewide project adoption, which is the County of Kern Norris Pedestrian and Railroad Safety project totaling \$9.8 million. All remaining Kern COG applications were considered for funding with the MPO share of the Cycle 6 ATP funding. At the February 16, 2023, the Kern Council of Governments Transportation Planning and Policy Committee adopted the MPO project list found on Page 3, making use of all available Cycle 6 ATP MPO funding. **Following the regional approval of the ATP Cycle 6 MPO list at the February 16, 2023 Kern COG Board meeting, staff has since prepared and submitted to the CTC, the final package of information as prescribed by the CTC, for its official list of MPO projects. This month, the CTC has scheduled a conference call on April 4, 2023, to discuss our MPO submittal. The results of that call will be shared by staff at the TTAC meeting.**

**Background:** At the August 18, 2022, California Transportation Commission (CTC) meeting, the Commission adopted a revised Fund Estimate for the Active Transportation Program (ATP) Cycle 6, which is now adopted. The approved revised Fund Estimate for the statewide ATP budget is now **\$1.7 billion** due to an infusion of funding from the recently approved 2022-23 state budget. The Kern COG guaranteed regional share of that statewide has been increased to **\$16.798 million**.

**Kern COG Policy Background** - CTC ATP Guidelines and Fund Estimate establish the project selection process and ATP programming capacity for the state and MPO share. When ATP first began, the Kern Council of Governments adopted its ATP project delivery policy that defers to the original state application review and ranking for all original state submitted applications. Kern COG does not do a separate ATP Call for Projects to use the MPO share and therefore does not adopt its own modified guidelines or conduct a separate MPO call for projects. Instead, Kern COG considers the remaining applications for MPO share funding following the ranking order as best as possible already established by the state-ranked applications not selected by the state.

**Submitted applications from Kern agencies** - The ATP Cycle 6 statewide call for projects resulted in 19 Kern region submitted applications for a value of **\$69 million**. They are listed on page 3. This table has been updated to include the ranking values for each application. The County of Kern project that ranked 91 is highlighted in yellow. This project has been approved by the state. The regionally approved MPO projects are highlighted in blue. This selection is based on Kern COG policy and has been financially constrained to the CTC adopted ATP Cycle 6 Fund Estimate. Kern COG's revised share is estimated at \$16,798,000 over a 4-year programming cycle from 2023-24 through 2026-27. The MPO project list includes a contingency list comprised of the partially funded Bakersfield project and then the Tehachapi project.

2024 Regional Transportation Improvement Program

DESCRIPTION:

Every two years in the odd-numbered year, regional transportation planning agencies are to submit a Regional Transportation Improvement Program (RTIP) to the California Transportation Commission (CTC) in December of the same odd-numbered year for their later approval early the following year.

DISCUSSION:

At their January 25– 26, 2023 meeting, the California Transportation Commission (CTC) initiated the 2024 Regional Transportation Improvement Program (2024 RTIP) process to develop a statewide 2024 State Transportation Improvement Program (2024 STIP) for projects of regional significance. The general order of this process is 1) CTC develops a statewide 5-Year regional share fund estimate; 2) CTC updates 2024 STIP guidelines; 3) regions submit RTIP's; and 4) the CTC consolidates RTIP's and approves the 2024 STIP.

**This month** –This month, Kern COG staff is circulating the updated KCOG RIP 60/40 baseline status. Also, for this month, staff is preparing for the April 26, 2023 workshop presentation. Draft fund estimate assumptions presented at March CTC meeting, will be a prime topic at the April Workshop.

The process for the region is to 1) establish new programming capacity defined by the state's fund estimate; 2) assess current regional project needs including cost estimate updates; 3) develop a proposed program of projects; and 4) regionally adopt the 2024 RTIP in November 2023, for submission to the CTC by December 15, 2023.

**Current 2022 STIP as Adopted** - Kern COG projects in the current 2022 STIP include highway capacity projects on State Routes 46, 58 and 99. The new SR 58 Truck Climbing Lane project was added to the 2022 STIP using CRRSAA / COVID funding. The Truck Climbing Lanes project on State Route 58 east of Bakersfield is considered a partnership project with Caltrans, with the intent of receiving SHOPP funding in future cycles for the construction phase. SR 46 widening work was advanced in the 2022 STIP to include construction funding for Segments 4B and 4C. These last 2 segments, once constructed, will complete the delivery of the last Phase 4, 5-mile segment. Phases 1, 2, and 3 are constructed. The Hageman Flyover project was programmed for construction in the 2022 RTIP. But the project has experienced delays. A STIP amendment was subsequently submitted by Kern COG to move funding from the Hageman Flyover to a new freeway to freeway connector project at the SR 58 and 99 freeway interchange. The STIP amendment was approved at the January 25-26, 2023 CTC meeting.

SR 58 Climbing Lanes	In the environmental review phase using CRRSAA/COVID funding.
NEW - SR 58/99 Connector	New project added to the 2022 STIP. This project was approved at the January 25-26, 2023, CTC meeting, as a STIP amendment and will fund the construction phase for the new connector. The City of Bakersfield is the lead for this work.

These projects are part of the 2022 State Transportation Improvement Program, and their funding activity is tracked by the CTC, every two years, through an updated document called Report of STIP Balances County and Interregional Shares, or the Orange Book. Attachment A of this report includes the 2022 Orange Book page for the Kern Region. The CTC will provide an update for the 2024 RTIP cycle sometime in the months ahead.



**Update of Kern COG Project Delivery Policies and Procedures** – In 2019, the Kern COG Board adopted the latest version of the Kern COG Project Delivery Policies and Procedures document which included updates to Chapters 1, 2 and 3. Chapter 3 focuses on the Regional Transportation Improvement Program process. The update included changes that provided consistency with STIP guidelines and other discretionary transportation programs.

### DESCRIPTION:

Kern COG staff has received a request for Congestion Mitigation Air Quality (CMAQ) Program funds. Kern COG staff has reviewed options for the CMAQ funding available.

### DISCUSSION:

At the March 1st Transportation Technical Advisory Committee (TTAC) meeting, the City of Taft presented a request to revise their Congestion Mitigation Air Quality (CMAQ) Program transit project. The TTAC and the Kern COG Board approved the changes. This left an unprogrammed balance of \$133,459 CMAQ in this fiscal year and \$860,210 CMAQ for next fiscal year (total \$993,669). Since then California City has received construction bids on their CMAQ project and is underfunded. California City is requesting an additional \$1,078,128 in CMAQ funds.

Original programming in the Federal Transportation Improvement Program (FTIP) for the City of California CMAQ project is shown below:

Kern COG staff seeks TTAC direction on which option to forward to the Transportation Planning Policy Committee.

**Option 1:** Select California City to receive \$993,669 in CMAQ funding. This option would not require an amendment to the FTIP. California City would request an E-76 AMOD. This option would allow the project to be delivered. This action uses all available CMAQ funds.

**Option 2:** Do nothing. This action leaves a balance of \$133,459 CMAQ unprogrammed for this fiscal year and \$860,210 for next fiscal year (total \$993,669). If the Kern COG Board approves this option, Kern COG could wait for projects in FY 23/24 to request advancement to FY 22/23 on a case-by-case basis. Kern COG could potentially lose funding since Kern COG staff has not received requests for CMAQ advancements.

Reminder: Regions can only use their own obligational authority until May 1st, then it is “first-come-first-served” until the obligational authority statewide is gone.

Kern COG staff does not have a recommendation due to existing policies in place:

- CMAQ policy requires an applicant council resolution that states: cost increases must be funded by the APPLICANT from other funds, and that APPLICANT does not expect any cost increases to be funded with additional CMAQ funding.

California City recommends Option 1.

DESCRIPTION:

Annual Caltrans funding is available for transit expansion projects that reduce greenhouse gas emissions for a very limited time through Low Carbon Transit Operations Program (LCTOP). The region is estimated to receive a total of \$2,369,913. Member agencies eligible for LCTOP funds were e-mailed the regional apportionment Wednesday, March 15, 2023.

DISCUSSION:

Kern COG staff received an apportionment estimate from Caltrans staff for the Kern Region for the Low Carbon Transit Operations Program. Caltrans will administer the LCTOP funding program in two accounts: 99313 (Kern COG Regional) and 99314 (Agency only) similar to the Proposition 1B program. The hard deadline to receive LCTOP allocation requests from member agencies and a Kern COG Board adopted a program of projects is estimated to be **Monday, May 1, 2023**.

**Expenditures Eligible for funding**

Funding for the program shall be expended to provide transit operating or capital assistance that meet all of the following criteria:

1. Expenditures supporting new expanded bus or rail services, or expanded intermodal transit facilities, and may include equipment acquisition, fueling, and maintenance, and other costs to operate those services or facilities.
2. The recipient transit agency demonstrates that each expenditure directly enhances or expands transit service to increase mode share.
3. The recipient transit agency demonstrates that each expenditure reduces greenhouse gas emissions.

**Example of Eligible Projects**

Expand transit services:

1. Implement bus rapid transit (for new routes or expansion of existing routes).
2. Increase service (extend transit routes, increase the frequency of service, and extend service hours).

3. Free or reduced-fare transit passes/vouchers.
4. Increase capacity on routes nearing capacity (add more buses, or rail cars to existing routes).
5. Purchase zero-emission or hybrid vehicles and equipment (e.g. buses, railcars, auxiliary electrical power units).
6. Expanded intermodal transit facilities.
7. Install new transit stops/stations that connect to bike/pedestrian paths.
8. Upgrade transit vehicles to support active transportation and encourage ridership (e.g., bicycle racks on buses; bicycle storage on rail cars).

Since the SCO has apportioned these monies for use in the fiscal year 2022-23, Kern COG staff suggests the following project timeline:

Present the FY 2022-23 SCO generated program of projects (POP) to the Transportation Technical Advisory Committee (TTAC) members at the **April 5, 2023** meeting.

Presentation and adoption of the Kern COG FY 2022-23 LCTOP POP and submittal of the member agencies allocation request **March 24, 2023 (to ensure making the April 20, 2023 Transportation Planning Policy Committee Agenda)**.

**All FY 2022-23 LCTOP completed project applications (with supporting documents) are due to Caltrans LCTOP staff by Monday, May 1, 2023.**

### DESCRIPTION:

Kern COG was awarded a grant from the California Energy Commission (CEC) to develop a Kern Medium- and Heavy-Duty Zero Emission Vehicle Infrastructure Blueprint. A final draft document is posted to the Kern COG website. Kern COG invites comments to be submitted by 10:00 am on April 10, 2023.

### DISCUSSION:

Kern Council of Governments in partnership with Gladstein, Neandross & Associates (GNA) and key stakeholders are working to develop a Blueprint that will identify major gaps in infrastructure for zero emission trucks and buses, community needs, available technology solutions, and ultimately a set of high impact 'shovel ready' infrastructure projects necessary for progress toward zero emission goods movement transportation in and through Kern County.

The California Energy Commission's (CEC's) Clean Transportation Program awarded Kern Council of Governments \$199,929 in April 2021 through the CEC solicitation GFO-20-601. "The primary purpose of the grant is to fund planning "blueprints" that will identify actions and milestones needed for implementation of medium- and heavy-duty (MD|HD) zero-emission vehicles (ZEVs) and the related electric charging and/or hydrogen refueling infrastructure to accelerate the deployment of MD|HD ZEVs and ZEV infrastructure with a holistic and futuristic view of transportation planning."

The project approach is designed to accelerate the region's clean transportation goals. GNA identified five high priority, transformational projects throughout Kern County that can stimulate additional outside investment, whether privately sourced or through public grant funding. The sites are: The City of Arvin Public Works, Frito-Lay on SR 58, Tejon Ranch Commerce Center, WattEV, and Wonderful Industrial Park.

The Blueprint recommends specific actions that regional stakeholders should take to meet project goals as well as a proposed electric vehicle infrastructure implementation schedule. You will find the document on the Kern COG website, <https://www.kerncog.org/?s=blueprint>. Comments are due by 10:00 am on April 10, 2023.

Kern COG staff will present a final version of the Kern EVCS Blueprint during the regularly scheduled Kern COG Transportation Planning and Policy Committee meeting on April 20, 2023.

#### Kern Medium- and Heavy-Duty (MD/HD) Zero-Emission Vehicle Infrastructure Blueprint Fact Sheet

##### The Blueprint

The Kern region is challenged by poor air quality, with emissions from transportation contributing the majority of ozone and particulate matter emissions. Replacing diesel and gasoline fueled vehicles on the road with zero-emission vehicles (ZEVs) will reduce pollution from transportation emissions. Many of the state and regional funding programs designed to reduce transportation emissions and improve air quality by incentivizing ZEVs are undersubscribed due to a lack of essential infrastructure buildout. To support the build-out of necessary infrastructure, Kern Council of Governments in partnership with Gladstein, Neandross & Associates (GNA), developing a Blueprint for medium and heavy duty zero emission truck infrastructure in Kern County.

##### Project Innovation and Advantages

The objectives of this project are to support the deployment of successful MD/HD ZEV infrastructure projects through regional ZEV infrastructure planning. This planning will identify high-impact projects for prioritization, show how resources can be focused on these initiatives, and identify other needed actions, such as workforce development to enable the deployment of zero-emission trucks. Through working with local stakeholder groups and industry interests the Blueprint will evaluate an equitable and actionable pathway toward zero-emission transportation technologies. The Blueprint plan will include analysis of the technologies being deployed, and an effective strategy for planning infrastructure to support the transition to zero-emission commercial vehicles in the county.

##### Anticipated Benefits to California

The Blueprint will engage community members, private, and public stakeholders to community needs, identify major gaps in infrastructure for zero-emission trucks and buses, available technology solutions, and ultimately a set of high-impact 'shovel-ready' infrastructure projects necessary for progress. The Blueprint will help maximize MD/HD ZEV deployment leading to the achievement of transportation related criteria emissions and greenhouse gas reduction goals in and through Kern County. Fostering zero-emission infrastructure in this critical transportation network will extend these benefits throughout California. The Blueprint will also serve as an example and template for other counties across the state to achieve similar energy and emission reduction goals.

- **Business Opportunities**  
New vehicle technologies will require additional support services, fuel and energy production, and zero-emission fueling infrastructure will be required in numerous and varied locations throughout the county.

MEASURE TARGET REQUIREMENT

### DESCRIPTION:

Caltrans has developed federal bridge and pavement condition performance measures (PM2) for jurisdictions with National Highway System (NHS) mileage (Kern, Bakersfield, Shafter, California City, Ridgecrest, and Caltrans), consistent with the state targets and the federal methodology.

### DISCUSSION:

Recent Federal transportation spending bills require states and metropolitan planning organizations (MPOs) like Kern COG to monitor bridge and pavement condition.

In consultation with Kern COG Staff, Caltrans has established statewide and Kern regional targets. The statewide targets are based on an aggregate of all MPO submitted targets. Caltrans has developed a tool to predict bridge and pavement conditions, which is used in conjunction with the MPOs to set the targets. The tool currently includes estimates of local expenditures from the state controller office as defaults. The condition predictions can be improved if the total expected annual planned expenditure amounts on NHS routes are obtained from each affected jurisdiction. MPOs were required to submit to Caltrans by September 3, 2021 and an update by June 22, 2022 the **NHS Pavement and Bridge Expected Performance Reporting Tool** results for development of the Caltrans Transportation Asset Management Plan (TAMP) and PM2

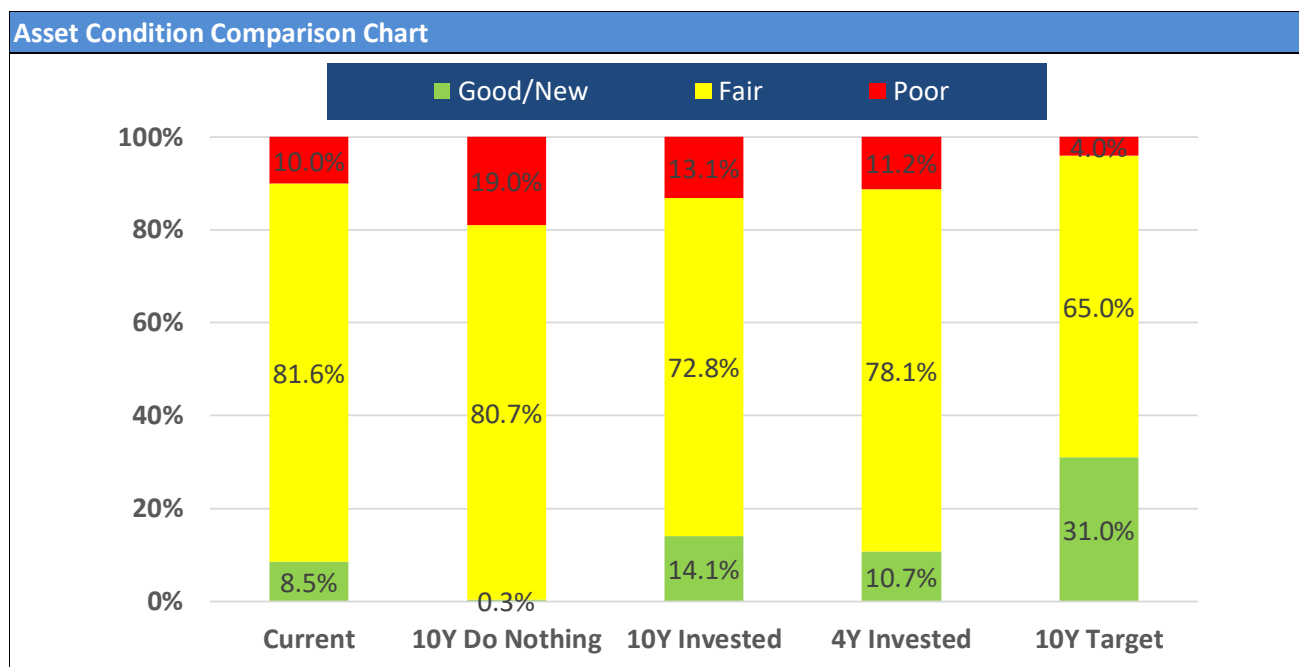
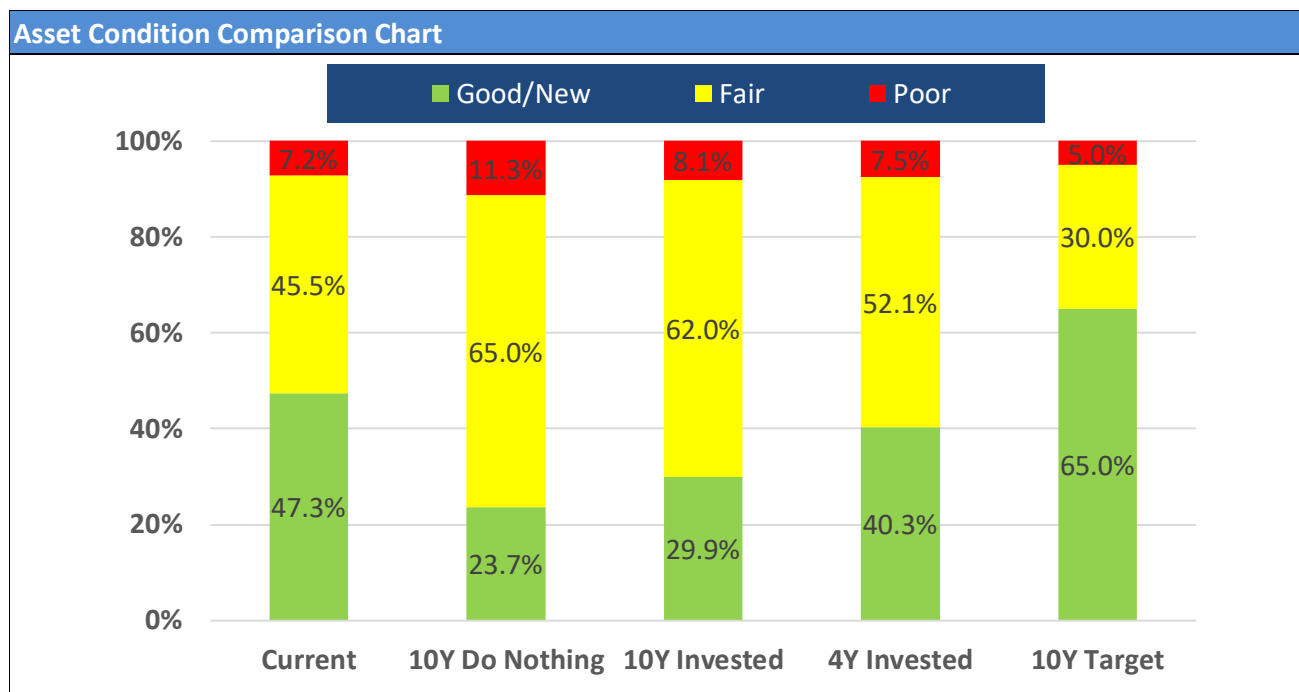




Figure 2 - Bridge Condition

Target setting. Kern COG submitted the targets by the deadlines while having obtained input by the affected member agencies. The Caltrans TAMP target is the 10-year invested target and the PM2 target is the 4-year invested target. The Caltrans goal is the 10-year target in the last column of figures 1 & 2.

If California does not achieve the established statewide aggregate 4-year targets, then the state is required to develop an improvement plan in consultation with the MPOs. We need to make “progress” towards the target as determined by the Federal Highways Administration (FHWA) through the PM 2 reporting process. In addition, the FHWA will review how MPOs are addressing and achieving their targets (or assisting the state in achieving targets) during their 4-year Federal Certification Review. Maintaining Federal MPO Certification is a prerequisite to receiving federal funding. Kern’s next four-year review is April 11-13, 2023. At that review Kern COG intends to report the long-time and successful use of Regional Surface Transportation Program (RSTP) and Highway Bridge Programs by our member agencies for state of good repair projects on federal aid system routes including the NHS. In addition, the Kern COG board has an adopted policy for approving an RSTP project that could be used to prioritize maintenance projects on local NHS routes should Caltrans monitoring demonstrate failure to meet the targets in Kern. Kern COG can also consider project delivery policies that help prioritize bridge and pavement maintenance on the NHS.

As bridge and pavement conditions improve on the local NHS routes, the targets will improve automatically. Member agencies are encouraged to promote projects and policies that improve the NHS routes in their jurisdictions to help the region to perform as good or better than targets for our region.

Figure 1 - Pavement Condition

## “Fix It First!” Pavement and Bridge Funding Strategy Stretches Road \$\$\$

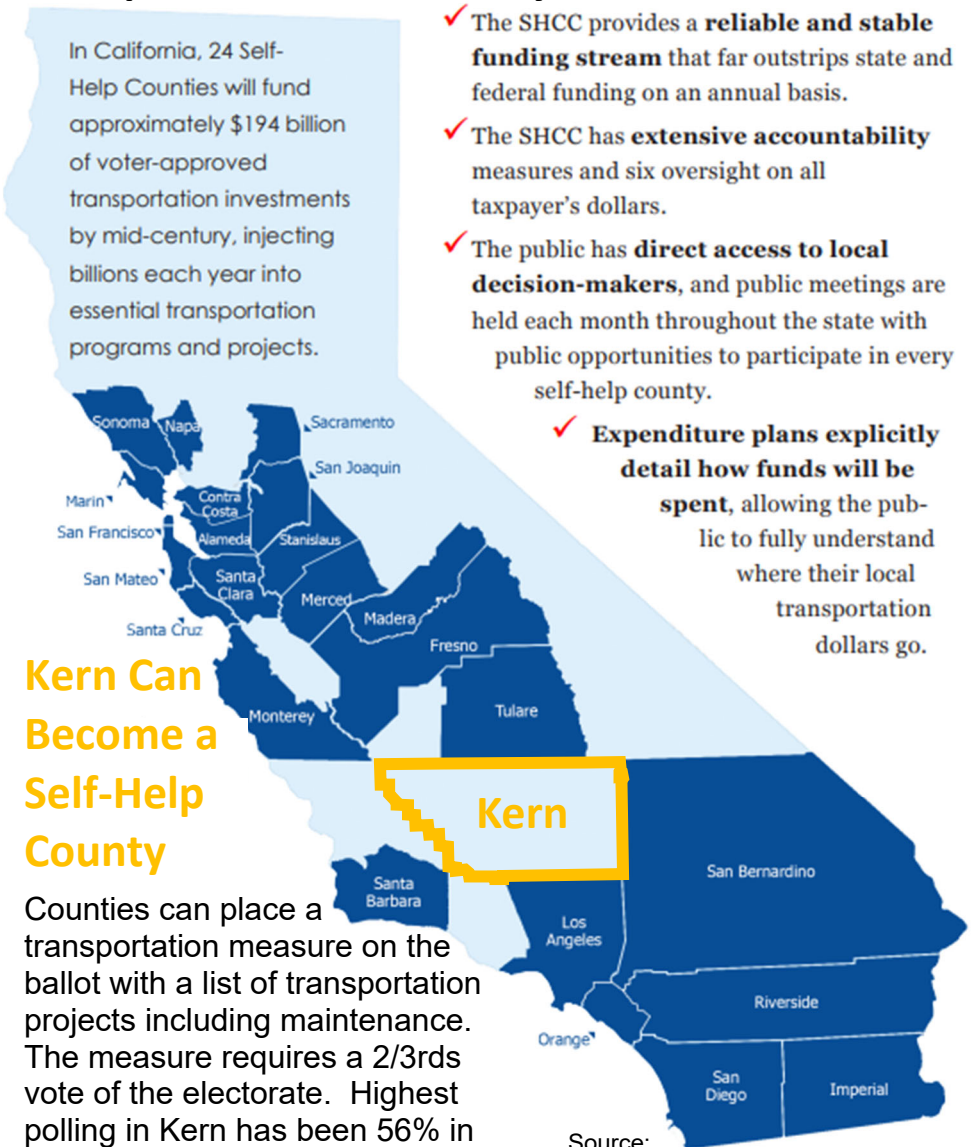
Preventive maintenance is crucial to roadway and bridge longevity. Expensive damage occurs to cars because of poor road conditions. The public demands that we “Fix it First.” Here are prioritized tips to catch up on roadway maintenance:

- 1) Oil all local roads every 2-years if possible – This stabilizes roads at their current level of degradation and helps prevent further deterioration.
- 2) After regular maintenance is fully funded, use every eligible road maintenance funding source to repair, rehabilitate, or rebuild the worst roadways in your jurisdiction even though the funds may be eligible for other projects.
- 3) Implement a Pavement Management System
- 4) Once all roadways are up to a Pavement Condition Index (PCI) of 80 out of 100, and regular maintenance is fully funded, SB1 LSRP, RSTP, & TDA funds can be freed up and used for other eligible transportation priorities.

Maintaining roads at 80 PCI is 1/10 the cost of having to rebuild a failed roadway, allowing a region to stretch its transportation funds for other priorities. Below are funding programs for pavement and bridge maintenance.

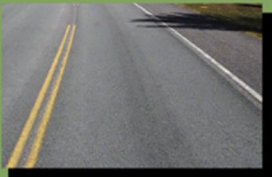

Total TDA related funding for the 2023-2024 fiscal year is estimated to be \$65,888,050.92.
