WHEREAS, the City Council of the City of Arvin by way of this public hearing is complying with California Public Utilities Code 99238.5 in addressing any unmet transit need that can be reasonably met; and

A Public Hearing to Consider and Approve A Resolution of the City Council of the City of Arvin to Affirm the Planning Commission's Action and Uphold the Imposition of the Condition Requiring the Payment of the Traffic Impact Fee – PUD (SDP) 1100BMB-Vanguard per Resolution No. APC 2022-07 Dated December 14, 2022. (City Manager)

The City Council has authorized a twenty percent (20%) reduction to the required Traffic Impact Fees. The following additional language has been placed in the Resolution: The Modification approved by the City Council provides the applicant with a twenty percent (20%) reduction to the required Traffic Impact Fees. The Development Impact Fee program allows payment of the development impact fees over the course of four (4) years. The first payment, equal to twenty percent (20%) of the total Development Impact Fees, is due one (1) year from the date of building permit issuance. Annual payments are due each year thereafter, on or before the date of building permit issuance, ending with final and full payment by three (3) years from the date of building permit issuance. Fee deferrals will be secured by one of the following:

- Assigned passbook or certificate of deposit; or
- Irrevocable letter of credit; or
- Surety bond; or
- Lien against the property; or
- Negotiable securities if approved by the City Council; or
- Reservation of funds within the escrow account of the senior lender; and

The City Council upon consideration of applicants' reason for the appeal and the request for waiver of the payment of Traffic Impact Fees and upon consideration of Staff's review, the Council rejects the applicants appeal and affirms, with modifications, the Planning Commission's actions. The Modification approved provides the applicant with a twenty percent (20%) reduction to the required Traffic Impact Fees and the City's policies allows payment of the development impact fees over the course of four (4) years.

Mayor Alindajao recognized the 2023 Central Section Division IV Champions – Cesar E. Chavez Wrestling team.

Mayor Alindajao recognized the Robert F. Kennedy Cheerleading Team winning 2023 USA Spirit & Junior Nationals/Collegiate Championships at the Anaheim Convention Center. Mayor Alindajao recognized Robert F. Kennedy High School for being designated as a 2022-2023 California Exemplary Dual Enrollment school by the California Department of Education. Mayor Alindajao recognized Delano High School being designated as a 2022-2023 California Exemplary Dual Enrollment school by the California Department of Education.

Presentation regarding services was provided by Delano Adult School with Mr. James Donahue.

ITEMS FROM THE PUBLIC

1. Abraham Jimenez thanked City Manager Maribel Reyna for the road repair on Cecil Avenue. Mr. Jimenez also thanked City Manager for the great job that was done with the road repair and that no one was hurt in the process.

Mr. Jimenez would like the city to consider adding a bench at the bus stop that is off County Line Road. Mr. Jimenez is unsure of the street name, but believes a bench is of great need because various individuals stand on rocks and in the yard.

Mr. Jimenez believes there are too many Holidays and upset that the transit not operating during President's Day.

Mr. Jimenez brought up another concern with transit. Mr. Jimenez believes that there are two transit drivers that are reckless, seem to want to rush back to the bus station, and the drivers park far from the curb when picking up passengers. Mr. Jimenez mentioned that he has taken his concerns to the Transit Manager and believes that the concerns are being addressed.

Mr. Jimenez would like to see the city population sign reinstalled.

- 2. Danny Sanchez congratulated the local schools on all the accomplishments. Mr. Sanchez shared concern that the Chief of the Delano Police Department has been absent on a regular basis. Mr. Gonzales questioned the reasons and the number of times the Chief has missed the various meetings. Mr. Gonzalez also questioned the Chief's plan to combat gangs and shootings and would like to know what the Chief has done to benefit the city and what the Chief's plans are for the future. Mr. Gonzalez is also concerned that the Chief is in a lawsuit with the county.
- 3. Yolanda Chacon is excited to see all the great things the youth is doing as well as all the teachers and community leaders. Ms. Chacon believes that is it inspiring to see the commitment that is coming from both and grateful for all the information given.
- 4. Fernando Bravo is concerned that the road on Cecil from Albany Street to Ellington Street has not been paved as he was told and has not seen any equipment on site.

(a) Pursuant to Government Code section 29530, this Board and the State Board of Equalization previously entered into an agreement that provides for the Board of Equalization to collect certain additional sales and use taxes in Kern County which taxes are returned to Kern County, administered by the regional transportation planning agency (the Kern Council of Governments), and used for the purposes specified in the Mills-Alquist-Deddeh Act (Public Utilities Code section 99200 et seq., also commonly referred to as the "Transportation Development Act"); and

(e) Kern Regional Transit prepared and filed with this Board a report summarizing and analyzing the comments received from the public with respect to the Regional Transportation Plan and the requirements of the Transportation Development Act. Based upon the analysis of the comments and suggestions received from Kern Regional Transit riders throughout Kern County, it is the conclusion of Kern Regional Transit that all transit needs identified in the report are either: 1) currently being met, 2) soon to be implemented, or 3) not reasonable to meet. The report also states that it is Kern Regional Transit's recommendation this Board find currently there are no unmet transit needs that are reasonable to meet within the County's area of responsibility; and

- (f) On May 23, 2023, this Board held a duly noticed public hearing at which:
- 1. the report and the recommendations of Kern Regional Transit were received and reviewed; and
- 2. all persons desiring to comment on transit needs were given the opportunity to address this Board.

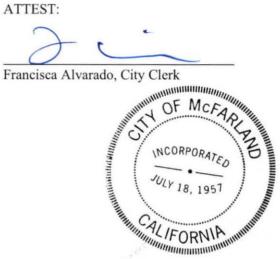

Excluded are 1) Those requests for minor operational improvements, and 2) Those improvements funded and scheduled for implementation in the following year. The term "reasonable to meet" is defined: A) Operational Feasibility: The requested improvement must be safe to operate, and there must be adequate roadways for transit vehicles; B) Duplication of Service: The proposed service shall not duplicate other transit services; C) Timing: The proposed service shall be in response to an existing rather than a future need; and D) Service must meet the legally required farebox ratio (PUC Sections 99268.2, 99268.5 and CAC Sections 6633.2, 6633.5) with fares close to fares of similar service."

WHEREAS, the City of Ridgecrest receives Transportation Development Act funds from Kern COG for various transportation uses; and

WHEREAS, before any allocation of Transportation Development Act funds is made for a purpose not related to public transportation services, a public hearing must be held to determine if there are any "unmet needs that are reasonable to meet" in the public transportation system: and

WHEREAS, a public hearing was duly advertised and held on March 15, 2023, to receive public comments regarding unmet transit needs that are reasonable to meet; and

WHEREAS, the City Council considered all available information, including the information presented at the public hearing on March 15, 2023.

WHEREAS, the City of Ridgecrest is required to submit findings from the annual unmet transit needs public hearing to Kern COG by the end of April 2023.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Ridgecrest that:

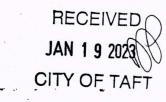

The term "reasonable to meet" is defined: A) Operational Feasibility: The requested improvement must be safe to operate, and there must be adequate roadways for transit vehicles; B) Duplication of Service: The proposed service shall not duplicate other transit services; C) Timing: The proposed service shall be in response to an existing rather than a future need; and D) Service must meet the legally required farebox ratio (PUC Sections 99268.2, 99268.5 and CAC Sections 6633.2, 6633.5) with fares close to fares of similar service."; and,

WHEREAS, a public hearing was duly advertised and held on March 21, 2023, to receive public comments regarding unmet transit needs that are reasonable to meet; and,

WHEREAS, the City of Wasco is required to submit findings from the annual unmet transit needs public hearing to Kern COG by the end of March 2023.
