B. HSR Updates

1. Project:

- a. HSR monthly and weekly meetings are continuing.
- b. HSR is currently in a review phase with specific design items with direction from new leadership.
- c. Right-of-way acquisitions are still moving forward.
- d. Joy Pinne has retired, and Jain Noopur will be taking her place.
- e. HSR and Jay Schlosser met in the previous week to discuss events happening at the federal level of HSR.
 - 1. The Federal Railroad Administration has agreed to put a stay on the spending of the funds that were promised while HSR is in litigation.
 - 2. Mr. Topete asked a question about the impact of the funds on the progress of the HSR. Ms. Rodriguez explained and clarified these effects for Mr. Topete.
 - 3. Mr. James asked a question regarding his concern about the risk of his project's timing. Mr. Lomax and Ms. Rodriguez will be discussing this matter and giving an update to Mr. James in the next meeting.
 - 4. Mr. Hurlbert also raised his concerns about how the funding may affect Wasco. Ms. Rodriguez reassured Mr. Hurlbert that Central Valley will be seeing those funds.
 - 5. Mr. Ball asked a question regarding the 7th standard mitigation project. Ms. Rodriguez, Mr. Lomax, and Mr. Champlin provided sufficient information.
