## **Online Regional Housing Needs Mapping Tool**

During the September RPAC meeting, staff from Rincon Consultants presented a draft of the online Housing Needs Mapping Tool. Staff and the RHNA consultant team is developing and maintaining a publicly viewable on-line mapping application, which will allow users to view the proposed RHNA unit allocations for each jurisdiction and to explore specific parcels to evaluate the potential number of units a parcel could support. The mapping tool will assist jurisdictions in the development and adoption of policies and process improvements to accelerate housing production. Staff from Rincon Consultants updated the online mapping tool. A presentation of the mapping tool will be scheduled at a future RPAC meeting.

#### **Corrected RHNA Table**

On December 22, 2022, Department of Housing and Community Development (HCD) emailed Kern COG about discrepancies they found in the Final RHNA. Staff and our consultant team have resolved the discrepancies which were rounding errors and have informed HCD. Staff also notified the affected local governments (County of Kern, California City, Shafter, Taft, and Wasco) of the discrepancies and provided them with the corrected RHNA. Please see Attachment 2 for the corrected Final RHNA table.

# **Regional Housing Data Report**

As part of the San Joaquin Valley Regional Early Action Program (REAP) comprehensive housing report, the REAP consultant team is contracted to produce housing data sets for all San Joaquin Valley jurisdictions. Local jurisdictions will be able to use the data to prepare the housing needs assessment required for the pending housing element updates. The data sets are linked to the online mapping tool. 
In addition, HCD provided housing element data packages to COG's and regions around the state to aid with the 6<sup>th</sup> cycle housing element updates. The data packages contain most of the data required in the housing needs assessment portion of the housing element update. These requirements are described in detail on HCD's website under the "Housing Needs" expandable window here: <u>Building Blocks | California Department of Housing and Community Development</u>. Certain data elements, such as farmworker and homeless populations are described at the county level, but should be supplemented with other sources so they may be quantified at the local level. 
# **Kern COG Housing Needs Mapping Tool User Guide**

The tool opens to the screen below. The default layers shown are the County Boundary and City Boundaries. Click on a City Boundary to view Regional Housing Needs Allocation (RHNA) data as well as download the jurisdiction specific San Joaquin Valley Regional Early Action Planning (SJV REAP) spreadsheet.




# **Data Categories**

In the upper right-hand corner of the tool are nine clickable category icons. Click on each icon to explore data layers available in that category.




#### **Viewing Data Layers**

To make a data layer viewable, click on the empty box to the immediate left of the data layer name. The data appears visually on the tool. Click the drop down arrow next to the layer to show the corresponding layer symbology. To remove the data layer from view, click the checked box to the immediate left of the layer name. The layer will be no longer be visible. Once a layer is selected for viewing, it will remain visible until the selection box is unselected, even when moving between data categories. The selection box must be unselected to remove a data layer from view.




## **Layer Order**

Multiple layers may be viewed at once, however the data layer at the top of the category in the right-hand side panel will be the predominantly visible layer. The order of available data layers within each category is adjustable. To change the order of a layer, click on the three dots to the right of the layer name in the right-hand side panel. Select "Move Up" or "Move Down" to move the selected layer.




#### **Transparency**

The transparency of each layer is adjustable to customize overlapping data layers. To change the transparency of a layer, click on the three dots to the right of the layer name in the right-hand side panel. Select "Transparency". An adjustable scale appears immediately above the selected layer. Once the desired transparency is set, click on any white space in the right-hand side panel to close the edit table.



## Data Window (Pop Up's)


The data layers within the tool are interactive. To view associated data and details for a particular data layer, click on the area of interest within the tool. Use the scroll bar in the information window to explore the available data.



#### **Basemap**

The tool defaults to a standard imagery basemap. The basemap can be changed by using the "Basemap Gallery" tab located in the upper left-hand corner. Road labels will appear when zooming in to a specific area.


- To change the application basemap, select the "Basemap Gallery" tool in the upper left-hand corner immediately underneath the address search bar.
- A list of available basemaps appears
- Select the desired basemap by clicking on the desired basemap thumbnail in the menu.




#### **Filters**

The filters on the left hand side allow the user to set specific parameters to search certain layers. To use the filters, select a drop down option or input a value range and toggle the filter on. Make sure the layer is visible in the right hand panel within the data tabs in the upper right hand corner.


Note: A generalized layer of all General and Specific Plans in Kern County to be used as an input layer for UPlan land use modeling.






## Parcel Filter


The Parcel layer default visibility range is set at the "County" level due to the size of the parcel dataset. It is recommended to keep the visibility range to County for best performance. Zoom in from the main map extent to make the parcel layer visible.




Once the parcel layer is visible on the map and a parcel filter is applied, only parcels within the filter parameters will be visible in the map.



It is also recommended to view filtered parcels in the attribute table. To view the attribute table, go to the parcel layer in the Boundaries data tab and select "View in Attribute Table".



This will allow the user to view the filtered parcels and zoom into specific parcels as needed. To do so, select the parcel in the attribute table (will be highlighted as shown below) by selecting the grey rectangle to the left of the APN. Use the "Zoom to" function to zoom into the selected parcel. **Due to the size of the parcel layer, please allow the tool time to filter the parcel dataset.**

UPDATE: SB 375 GREENHOUSE GAS EMISSION REDUCTION FROM PASSENGER VEHICLES AND ADOPTION TIMELINE FOR THE 2026 RTP

#### **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets.

#### **DISCUSSION:**

This discussion provides update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS).

January 20, 2023 – The California Air Resources Board (ARB) responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A follow-up meeting was schedule for January 24, 2023 to further clarify the questions. ARB is required to provide their finding and recommendations 2 months after the submittal is found to be complete.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range program air quality conformity was federally approved. The 2023 FTIP "CTIPS Report" and "Grouped Project Listing" weblinks are available at: https://www.kerncog.org/2023-ftip/.

November 29, 2022 – Kern COG submitted the technical methodology data package to the California Air Resources Board (ARB).

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available online at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

March 22, 2018 - ARB adopted new SB375 Targets for the third cycle RTP/SCS to be effective October 1, 2018. Next ARB target setting will be during the 2022-2026 window.

June 13, 2017 - ARB released proposed targets that were 2 percentage points higher than what Kern COG recommended for 2035. - 2. Affirmatively Furthering Fair Housing, and
- 3. Reducing Vehicle Miles Traveled (VMT)

Ms. Napier also stated that Threshold Requirements include:

- 1. Significant Beneficial Impact,
- 2. Equitable Targeted Outreach Unique to REAP 2.0, and
- 3. Suballocation Methodology must be approved by the Department by March 31, 2023.

This item was presented to the TTAC at the 10:00 a.m. meeting and the TTAC recommendation was to conduct an in-person workshop beginning at 10:00 a.m. Wednesday, September 28, and to submit projects to Ms. Napier by close of business on September 19 along with a paragraph for each project on how it meets the three objectives listed above.

The RPAC agreed that the in-person workshop was necessary to get everyone on board with what projects to move forward to the application.

#### VI. REGIONAL EARLY ACTION PLANNING 2.0 GRANT FUNDING (Napier)

<u>Comment:</u> Ms. Napier stated that two workshops were conducted, Wednesday September 28, and Wednesday, October 12, 2022. During both workshops, each Agency was allotted time to present their project and answer questions. Ms. Napier reviewed the Grant Timeline and Workshop Results. The results of the Survey conducted to rank the projects is as follows (with [1] being the most desirable project):

City of Arvin	TCC Collaborative	3.417
City of Bakersfield	Bakersfield Senior Center	1.5
City of Bakersfield	Hageman Bike Path	4.583
City of Shafter	Tract 6713	2.5
City of Wasco	Alley Reconstruction (ADUs)	3.5

Ms. Napier then reviewed the comments submitted by participants:

- 1. I would like to take this opportunity to reiterate our concern, as also pointed out by other agencies, with Arvin's project and their ability to deliver their project within the parameters and deadlines established with the funding requirements of REAP 2.0. I don't mean to say that their staff is not capable of delivering projects, it is rather the timeline of their permits, other funding process and delivery of their project in less than 2 years.
- 2. I would like for the top 5 projects to be submitted with the full \$17mil request. However, in order to fit the \$12.6mil budget, I only recommend the top 4 projects submitted with adjustments on both housing projects from Arvin and Bakersfield. I would recommend to fully fund Shafter and Wasco's projects... subtract Arvin's \$1.2mil for the transportation hub bringing their request down to \$6.1mil... then give the remaining \$5,590,482 to the Bakersfield Senior Center Project, more specifically for the larger mixed use development.
- 3. I have included ranking for projects with adjusted dollar amounts to meet the \$12,670,717 allocation and without adjusted amounts totaling the full \$17,280,235 ask. Adjustments:

City of Arvin \$5,000,000 (Leveraged funds \$4,000,000; Water, Sewer, Power \$1,000,000)

City of Bakersfield BSC \$6,690,483

City of Bakersfield Bike Path \$0

City of Shafter \$230,234.59

City of Wasco \$750,000

Total Funding \$12,670,717.59

My take on asking for more money than our allotment is that it is potentially risky since our project list does not lend itself to just dropping the bottom project to fit within the \$12 million allocation. In that case, we would end up having to figure out what to cut and how to cut it anyway if the State doesn't have additional funds available or if they come up with some alternate method of disbursing additional funds.

Ms. Napier also discussed a webinar that she participated in on Tuesday, November 1, with CALCOG and other California MPOs. She stated that everyone is concerned about the timeline for the grant and the ability of HCD to respond in a timely manner to the December application process and provide timely agreements to the applicants to meet the very tight timeline. The meeting was then turned over to Chairman Schlosser.

Chairman Schlosser asked if there were any comments from the audience. One comment was received virtually from Troy Hightower. Chairman Schlosser then asked if any TTAC or RPAC members had questions. Each applicant was asked a series of questions concerning their projects (generally the questions were the same to each applicant). After the questioning was complete, Chairman Schlosser asked if there was a suggestion on how to proceed. RPAC Chairman Staples stated that he was ready to make a motion. After final questions from Committee Members, the following action was taken:

<u>Action:</u> RPAC Chairman Staples made a motion to recommend to the Kern COG Board that a grant application be submitted to HCD in the amount of \$12,670,717 for the following projects and amounts:

\$750,000 Wasco Alley Rehabilitation for ADUs

• \$230,235 Shafter Tract 6713

• \$6,000,000 Bakersfield Senior Center Affordable Senior Housing & Facility

\$5,690,482 Arvin "Keeping it Green in the San Joaquin"

and create a contingency list with the application to include:

\$3,000,000 Bakersfield Hageman Bike Path\$1,609,518 Remained of Arvin Project

Motion seconded by Committee Member Esselman with a unanimous roll call vote.

Housing Element Annual Progress Report Update

#### **DESCRIPTION:**

Kern's jurisdictions are required to provide Annual Progress Reports (APRs) to the California Department of Housing and Community Development (HCD) on their progress toward state mandated Regional Housing Needs Assessment (RHNA) goals by April 1, 2023 or risk becoming ineligible for many state grants.

#### DISCUSSION:

#### RHNA/RTP/SCS

Legislative changes have linked the Regional Transportation Plan (RTP), Sustainable Communities Strategies (SCS) and the RHNA. The RHNA is updated every 8 years relative to the RTP update. The current RHNA, the 6<sup>th</sup> Cycle, was adopted by Kern COG alongside the 2022 RTP in July 2022. The RHNA was approved by HCD on August 18<sup>th</sup>, 2022.

#### **Housing Element and Annual Progress Reports**

By operation of law the Housing Element updates are due to Housing and Community Development (HCD) within 18 months of the RTP adoption, that date being December 31st, 2023. Each of the jurisdictions with land use authority must prepare an Annual Progress Report (APR) and submit it to HCD. The APRs provide HCD with metrics to measure the jurisdiction's status and progress in implementing its housing element. If jurisdictions do not submit their annual APRs, they may become ineligible for certain housing grants and other funding. The attached table provides a status of the submissions of APRs in Kern. With the adoption of Assembly Bill 2653 (2022) the APR process is enforceable by HCD and the Attorney General's office.

Kern Area Regional Goods-movement (KARGO) Sustainability Study Update

# **DESCRIPTION:**

The Phase II KARGO Sustainability Study, a project looking to address the needs and impacts of increased freight movement in the region, is requesting local jurisdictions review and verify current development impact fee rates in the attached report.

#### DISCUSSION:

#### Intent

The Kern region has a growing goods movement trade hub and logistics industry, with now over 52 million sq. ft. of industrial, warehousing and processing facilities, and has been growing at 4 million sq. ft. per year since 2014. The intent of the KARGO2 study is to work with community stakeholders including the City of Shafter, City of Bakersfield, Kern County, Caltrans, and railroads to evaluate strategies to improve the sustainability of growing regional goods movement activity in Kern County and impacts on the transportation system and surrounding communities including disadvantaged communities. The study is analyzing funding mechanisms for the strategies and develop an outreach program to engage and communicate findings to stakeholders and disadvantaged communities.

## **Overall Project Objectives**

Kern Council of Governments in partnership with its member agencies are studying "last mile" goods movement in the rapidly growing Shafter/BFL International Airport trade hub. The study has the following seven overarching objectives:

- I. Build on the extensive, recent public outreach in the region to all communities, including representatives of disadvantaged communities with the goal of developing an "informed consent" on expanding and mitigating goods movement opportunities in the region.
- II. Use the Phase I KARGO Sustainability Circulation Study as a framework for the Phase II study.
- III. Focus on mitigation strategies for the growing goods movement in the region.

- IV. Evaluate strategy for a Regional Logistics Mitigation Fee and develop Nexus Study including forecasting market demand and the impact of the fee on that demand.
- V. Develop and consider reduced fee incentives for implementation of logistics strategies such as zero emission technology, or intermodal rail service to the ports and/or the Midwest.
- VI. Identify strategies related to technology as well as other non-traditional strategies to mitigate impacts to all communities in the region.
- VII. Identify and develop commute options for employees.

This memorandum documents the existing development impact fee programs for jurisdictions in Kern County. The purpose of this documentation is to determine the total impact fee burden for the identified agencies to inform the exploration of other potential funding mechanisms to support infrastructure needed for future developments as part of the Phase II KARGO effort.

# **Existing Development Impact Fee Programs**

The sections below summarize the existing transportation impact fee programs for the following jurisdictions/agencies in Kern County:

- · City of Bakersfield
- City of Tehachapi
- Kern County Rosamond-Willow Springs Specific Plan Areas
- City of Arvin
- City of Delano
- City of McFarland

The following jurisdictions were reviewed and did not have information available regarding development impact fee programs: California City, City of Maricopa, City of Shafter, City of Wasco. According to the City of Ridgecrest municipal code, development impact fees are assessed for fire facilities, traffic impacts, parks, law enforcement, and storm drainage. However, the fee schedule is not available.



# **City of Bakersfield**

**Table 1** shows the non-Transportation development impact fees in the City of Bakersfield, and **Table 2** shows the Transportation development impact fees. The Transportation development impact fees have been jointly adopted with Kern County. **Figure 1** shows the core area for which a lower fee rate applies.



## **City of Tehachapi**

Like the City of Bakersfield, the City of Tehachapi has a Transportation Impact Fee Program that is jointly adopted with Kern County and features a core area for which a lower fee rate applies. According to the Kern County Code of Ordinances, the Tehachapi Region Core Area includes, "those portions under County jurisdiction enclosed within the following described boundary: The Point of Beginning is at the intersection of the centerline of Dennison Road and southline of the State Route 58 right-of-way; thence proceeding southerly along said centerline of Dennison Road to East Quarter Corner of Section 28, Township 32 South, Range 32 East, MDM (aka Abajo Road or Pinon Road alignment); thence proceeding westerly along said midsection section lines of Sections 28, 29 to a point on the centerline of Tucker Road; thence northerly along said center line of Tucker Road to the southline of the State Route 58 right-of-way; thence proceeding easterly along said southline of the State Route 58 right-of-way to the centerline of Dennison Road, the Point of Beginning." **Table 3** shows the Transportation development impact fees in the City of Tehachapi.

The City of McFarland published a Development Impact Fee Update Study in November 2020 which provided an analysis of development impact fees needed to support future development in the City of McFarland through 2040. **Table 10** below summarizes the development impact fees that meet the City's identified needs and comply with the requirements of the Mitigation Fee Act, and **Table 11** summarizes the City's proposed impact fee schedule. The parks and recreation facilities fees and traffic facilities fees have been reduced to lower the overall fee burden. City staff identified the target fee level for single family units, and the fees for other land uses were reduced proportionally.

## **Online Regional Housing Needs Mapping Tool**

During the September RPAC meeting, staff from Rincon Consultants presented a draft of the online Housing Needs Mapping Tool. Staff and the RHNA consultant team is developing and maintaining a publicly viewable on-line mapping application, which will allow users to view the proposed RHNA unit allocations for each jurisdiction and to explore specific parcels to evaluate the potential number of units a parcel could support. The mapping tool will assist jurisdictions in the development and adoption of policies and process improvements to accelerate housing production. Staff from Rincon Consultants updated the online mapping tool. A presentation of the mapping tool will be scheduled at a future RPAC meeting.




## **Kern COG Housing Needs Mapping Tool User Guide**

The tool opens to the screen below. The default layers shown are the County Boundary and City Boundaries. Click on a City Boundary to view Regional Housing Needs Allocation (RHNA) data as well as download the jurisdiction specific San Joaquin Valley Regional Early Action Planning (SJV REAP) spreadsheet.




## **Data Categories**

In the upper right-hand corner of the tool are nine clickable category icons. Click on each icon to explore data layers available in that category.




## **Viewing Data Layers**

To make a data layer viewable, click on the empty box to the immediate left of the data layer name. The data appears visually on the tool. Click the drop down arrow next to the layer to show the corresponding layer symbology. To remove the data layer from view, click the checked box to the immediate left of the layer name. The layer will be no longer be visible. Once a layer is selected for viewing, it will remain visible until the selection box is unselected, even when moving between data categories. The selection box must be unselected to remove a data layer from view.




## **Layer Order**

Multiple layers may be viewed at once, however the data layer at the top of the category in the right-hand side panel will be the predominantly visible layer. The order of available data layers within each category is adjustable. To change the order of a layer, click on the three dots to the right of the layer name in the right-hand side panel. Select "Move Up" or "Move Down" to move the selected layer.



## **Transparency**

The transparency of each layer is adjustable to customize overlapping data layers. To change the transparency of a layer, click on the three dots to the right of the layer name in the right-hand side panel. Select "Transparency". An adjustable scale appears immediately above the selected layer. Once the desired transparency is set, click on any white space in the right-hand side panel to close the edit table.



## Data Window (Pop Up's)


The data layers within the tool are interactive. To view associated data and details for a particular data layer, click on the area of interest within the tool. Use the scroll bar in the information window to explore the available data.



## **Basemap**

The tool defaults to a standard imagery basemap. The basemap can be changed by using the "Basemap Gallery" tab located in the upper left-hand corner. Road labels will appear when zooming in to a specific area.


- To change the application basemap, select the "Basemap Gallery" tool in the upper left-hand corner immediately underneath the address search bar.
- A list of available basemaps appears
- Select the desired basemap by clicking on the desired basemap thumbnail in the menu.



#### **Filters**

The filters on the left hand side allow the user to set specific parameters to search certain layers. To use the filters, select a drop down option or input a value range and toggle the filter on. Make sure the layer is visible in the right hand panel within the data tabs in the upper right hand corner.






## Parcel Filter


The Parcel layer default visibility range is set at the "County" level due to the size of the parcel dataset. It is recommended to keep the visibility range to County for best performance. Zoom in from the main map extent to make the parcel layer visible.




Once the parcel layer is visible on the map and a parcel filter is applied, only parcels within the filter parameters will be visible in the map.



It is also recommended to view filtered parcels in the attribute table. To view the attribute table, go to the parcel layer in the Boundaries data tab and select "View in Attribute Table".



This will allow the user to view the filtered parcels and zoom into specific parcels as needed. To do so, select the parcel in the attribute table (will be highlighted as shown below) by selecting the grey rectangle to the left of the APN. Use the "Zoom to" function to zoom into the selected parcel. **Due to the size of the parcel layer, please allow the tool time to filter the parcel dataset.**

## **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets.

## **DISCUSSION:**

This discussion provides update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

February 17, 2023 – Kern COG submitted responses to the California Air Resources Board (ARB) January 20, 2023 questions on Kern COG's technical methodology package provided to ARB on November 29, 2023. ARB is required to provide their finding and recommendations 2 months after the submitted package is found to be complete.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A follow-up meeting was held on January 24, 2023 to further clarify the questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range program air quality conformity was federally approved. The 2023 FTIP "CTIPS Report" and "Grouped Project Listing" weblinks are available at: <a href="https://www.kerncog.org/2023-ftip/">https://www.kerncog.org/2023-ftip/</a>.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available online at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

#### **DESCRIPTION:**

Kern COG was awarded a grant from the California Energy Commission (CEC) to develop a Kern Mediumand Heavy-Duty Zero Emission Vehicle Infrastructure Blueprint. A final draft document is posted to the Kern COG website. Kern COG invites comments to be submitted by 10am on April 10, 2023.

#### **DISCUSSION:**

Kern Council of Governments in partnership with Gladstein, Neandross & Associates (GNA) and key stakeholders are working to develop a Blueprint that will identify major gaps in infrastructure for zero emission trucks and buses, community needs, available technology solutions, and ultimately a set of high impact 'shovel ready' infrastructure projects necessary for progress toward zero emission goods movement transportation in and through Kern County.

The California Energy Commission's (CEC's) Clean Transportation Program awarded Kern Council of Governments \$199,929 in April 2021 through the CEC solicitation GFO-20-601. "The primary purpose of the grant is to fund planning "blueprints" that will identify actions and milestones needed for implementation of medium- and heavy-duty (MD|HD) zero-emission vehicles (ZEVs) and the related electric charging and/or hydrogen refueling infrastructure to accelerate the deployment of MD|HD ZEVs and ZEV infrastructure with a holistic and futuristic view of transportation planning."

The project approach is designed to accelerate the region's clean transportation goals. GNA identified five high priority, transformational projects throughout Kern County that can stimulate additional outside investment, whether privately sourced or through public grant funding. The sites are: The City of Arvin Public Works, Frito-Lay on SR 58, Tejon Ranch Commerce Center, WattEV, and Wonderful Industrial Park.

The Blueprint recommends specific actions that regional stakeholders should take to meet project goals as well as a proposed electric vehicle infrastructure implementation schedule. Kern Medium- and Heavy-Duty (MD/HD) Zero-Emission Vehicle Infrastructure Blueprint Fact Sheet

## The Blueprint

The Kern region is challenged by poor air quality, with emissions from transportation contributing the majority of ozone and particulate matter emissions. Replacing diesel and gasoline fueled vehicles on the road with zero-emission vehicles (ZEVs) will reduce pollution from transportation emissions. Many of the state and regional funding programs designed to reduce transportation emissions and improve air quality by incentivizing ZEVs are undersubscribed due to a lack of essential infrastructure buildout. To support the build-out of necessary infrastructure, Kern Council of Governments in partnership with Gladstein, Neandross & Associates (GNA), developing a Blueprint for medium and heavy duty zero emission truck infrastructure in Kern County.

## Project Innovation and Advantages

The objectives of this project are to support the deployment of successful MD/HD ZEV infrastructure projects through regional ZEV infrastructure planning. This planning will identify high-impact projects for prioritization, show how resources can be focused on these initiatives, and identify other needed actions, such as workforce development to enable the deployment of zero-emission trucks. ## Anticipated Benefits to California

The Blueprint will engage community members, private, and public stakeholders to community needs, identify major gaps in infrastructure for zero-emission trucks and buses, available technology solutions, and ultimately a set of high-impact 'shovel-ready' infrastructure projects necessary for progress. The Blueprint will help maximize MD/HD ZEV deployment leading to the achievement of transportation related criteria emissions and greenhouse gas reduction goals in and through Kern County. Fostering zero-emission infrastructure in this critical transportation network will extend these benefits throughout California. The Blueprint will also serve as an example and template for other counties across the state to achieve similar energy and emission reduction goals.



## Specific Benefits

### Business Opportunities

New vehicle technologies will require additional support services, fuel and energy production, and zero-emission fueling infrastructure will be required in numerous and varied locations throughout the county.

#### Job Creation

Jobs will be created in the construction and development of the additional fueling and charging infrastructure, and support personnel hired to maintain the industry will comprise a large employment sector in addition to the local training and education that will need to be implemented in the region.

## Greenhouse Gas Emissions and Climate Pollutant Reduction

Zero-emission transportation in the commercial sector is the most direct strategy for reducing emission in Eastern Kern County and the San Joaquin Valley airsheds. Furthermore, the availability of zero-emission fueling infrastructure will allow long distance goods movement vehicles that traverse the region to be able to charge and fuel in Kern County, thereby bringing the benefits to surrounding regions.

### Petroleum Displacement

Every vehicle mile traveled by zero emission MD/HD vehicles that use the infrastructure planned in this Blueprint will directly reduce the region's and the state's petroleum consumption.

#### Impact to Low Income and Disadvantaged Communities

Low Income and Disadvantaged Communities will benefit from the air quality improvements from displaced petroleum consumption. Lower-cost electric fuels will become more readily available for the county. Finally, the jobs created from the new a burgeoning industry will provide economic opportunity for Kern County.

## Localized Health Impact

The existing poor air quality in Kern County will benefit directly from cleaner vehicles operating in, around, and through the region, and Low Income and Disadvantaged Communities that are most prone to poor air quality will benefit from the plans made through this zero emission MD/HD infrastructure Blueprint

One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memo. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18. ARB is required to provide their finding and recommendations 2 months after the submitted package is from November 29, 2023 is found to be complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the California Air Resources Board (ARB) January 20, 2023 questions on Kern COG's technical methodology package provided to ARB on November 29, 2023.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A follow-up meeting was held on January 24, 2023 to further clarify the questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range program air quality conformity was federally approved. The 2023 FTIP "CTIPS Report" and "Grouped Project Listing" weblinks are available at: https://www.kerncog.org/2023-ftip/.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

The Draft 2023 Public Involvement Procedures and Policies (PIP) were presented at the May 3<sup>rd</sup> RPAC meeting.

The PIP provides guidance for Kern Council of Governments' (Kern COG) elected officials and staff in public participation and interagency consultation throughout the regional planning process. It contains the agency policies, guidelines and procedures Kern COG uses in developing the metropolitan planning process. This includes the development and approval of the Regional Transportation Plan, Regional and Federal Transportation Improvement Program, and environmental review documentation related to growth, transportation, air quality, and any product prepared by Kern COG staff that statutorily requires public participation, or for which the Kern COG Board of Directors determines is necessary. Kern COG carries out its transportation and air quality planning responsibilities in a continuing, cooperative and comprehensive manner in conformance with Federal and State law that determine how Metropolitan Planning Organizations (MPOs) provide for early consultation and public participation.

Prior to development of the 2026 RTP, Kern COG is updating the Public Involvement Policies and Procedures (PIP) to include the latest Federal and State requirements and input from participating agencies and stakeholders. The Draft 2023 PIP is posted at https://www.kerncog.org/policies/

The 2017 California RTP Guidelines as well as Kern COG's 2019 PIP require a forty-five (45) day public comment period prior to adoption of the 2023 PIP. The 45-day public comment period began May 1<sup>st</sup>, 2023 and closes June 15<sup>th</sup>, 2023.

Additional roundtable meetings will be held in Fall of 2023 to gather input for specific strategies for public participation during the 2026 RTP development outreach in accordance with the 2023 PIP.

**Enhanced Infrastructure Financing** District (EIFD)

- ▶ Provide an emerging form of tax increment financing available to local public
- May be formed over a defined area (the district), including non-contiguous areas, by a city, county, or joint powers authority (JPA), to capture incremental increases in property tax revenue from future development and assessed value appreciation
  - ▶ Without an EIFD, this revenue would accrue to the City's General Fund (or other property-taxing entity revenue fund
  - ▶ EIFDs do not provide access to property tax revenue beyond the share agreed to by participating jurisdictions (e.g., City and County)
- ▶ Establishment requires approval by every local taxing entity that will contribute its property tax increment
- ▶ Revenues may be used to provide funding and financing for broad range of infrastructure projects, provided those projects have a useful life of 15 years and are of 'community-wide' significance

# **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets.

# DISCUSSION:

This discussion provides an update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

May 19, 2023 – California Air Resources Board (ARB) staff acknowledged receipt of the requested transmittal letter signed by the Kern COG Chair, and associated TPPC staff report. ARB staff indicated they would provide a status update by May 31, and try to meet Kern COG's request for an expedited review by June 8, but that they could not commit to any earlier than June 27.

May 5, 2023 - Kern COG submitted a draft of a Kern COG TPPC staff report and transmittal letter to ARB with a request for the Kern COG Chair to sign. The item was approved by the Board on May 18, 2023. The letter documents technical changes that do not affect the adopted RTP/SCS

text or conclusions. The document contains updates from the November 2022 SCS technical data submittal to ARB consistent with ARB guidelines.

May 1, 2023 – The Kern COG Executive Director and other COG directors from the San Joaquin Valley met with the SJV representative on the California Air Resources Board. At that meeting ARB staff indicated that Kern was close to receiving the acceptance finding for their SCS.

April 26, 2023 – Kern COG submitted to ARB a cover letter and revised technical methodology data submittal with all the requested updates since the November data submittal. ARB requested that the Kern COG's chair's signature be approved by the Kern COG Board,

April 17, 2023 – Kern COG web conferenced with ARB staff for the 14<sup>th</sup> time in 3 years to discuss the 2022 SCS technical methodology. One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memo. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18. ARB is required to provide their finding and recommendations 2 months after the submitted package from November 29, 2023 is found to be complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the California Air Resources Board (ARB) January 20, 2023 questions on Kern COG's technical methodology package provided to ARB on November 29, 2023.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A follow-up meeting was held on January 24, 2023 to further clarify the questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range program air quality conformity was federally approved. The 2023 FTIP "CTIPS Report" and "Grouped Project Listing" weblinks are available at: <a href="https://www.kerncog.org/2023-ftip/">https://www.kerncog.org/2023-ftip/</a>.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available online at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

UPDATE: SB 375 GREENHOUSE GAS EMISSION REDUCTION FROM PASSENGER VEHICLES AND ADOPTION TIMELINE FOR THE 2026 RTP

# **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets. This item was shared with the Regional Planning Advisory Committee.

# **DISCUSSION:**

This discussion provides an update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

August 10, 2023 - California Air Resources Board (ARB) staff announced at the quarterly San Joaquin Valley Inter-Agency Consultation meeting that Kern, Stanislaus, and Tulare COGs have received their approval and will receive official documentation in September. Fresno and San Joaquin COGs have completed their reviews and are in the process of making some required board actions before they can receive their official approval. Kings, Madera and Merced are still under review by ARB staff.

July 26, 2023 – 2026 RTP/SCS Roundtable Meeting was held for environmental, equity, business & industry groups on the public outreach process at Kern COG and included 14 representatives from the Delores Huerta Foundation, Central California Asthma Collaborative, Sierra Club, Home Builders Association, Golden Empire Transit, Caltrans, County Public Works, and staff from the cities of McFarland, Taft, and Wasco.

July 13, 2023 - ARB staff emailed Kern COG and the California, the final acceptance letter is still working its way through upper management reviews and may not be issued till September due to staffing and vacation issues.

June 15, 2023 – Kern COG Board approved the 2023 Public Involvement Procedures document after a 45-day public review. The document is online at <a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>.

June 13, 2023 – ARB staff emailed Kern COG and the California Transportation Commission that "the SCS is officially approved." However, the final acceptance letter is still working its way through upper management reviews and will take several weeks before it is issued.

May 19, 2023 – ARB staff acknowledged receipt of the requested transmittal letter signed by the Kern COG Chair, and associated TPPC staff report. ARB staff indicated they would provide a status update by May 31, and try to meet Kern COG's request for an expedited review by June 8, but that they could not commit to any date earlier than June 27.

May 5, 2023 - Kern COG submitted a draft of a Kern COG TPPC staff report and transmittal letter to ARB with a request for the Kern COG Chair to sign. The item was approved by the Board on May 18, 2023 and signed by the Chair. The letter documents technical changes that do not affect the adopted RTP/SCS text or conclusions. The document contains updates from the November 2022 SCS technical data submittal to ARB consistent with ARB guidelines.

May 1, 2023 – Kern COG circulated the draft Public Involvement Procedure for 45-day public review period to be concluded on June 15. In addition, the Kern COG Executive Director and other COG directors from the San Joaquin Valley met with the SJV representative on the California Air Resources Board. At that meeting ARB staff indicated that Kern was close to receiving the acceptance finding for their SCS.

April 26, 2023 – Kern COG submitted to ARB a cover letter and revised technical methodology data submittal with all the requested updates since the November data submittal. ARB requested that the Kern COG's chair's signature be approved by the Kern COG Board,

April 17, 2023 – Kern COG web conferenced with ARB staff for the 14<sup>th</sup> time in 3 years to discuss the 2022 SCS technical methodology. One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memorandum. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18, 2023. ARB is required to provide their finding and recommendations 2 months after the submitted package from Nov. 29, 2023 is found complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the ARB January 20, 2023 questions on Kern COG's technical methodology package provided to ARB on November 29, 2023.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A meeting was held on January 24, 2023 to clarify questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range transportation program air quality conformity was federally approved. November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

## **DESCRIPTION:**

The 2022 Regional Transportation Plan (RTP)/Sustainable Communities Strategy (SCS) includes a strategy to provide sub regional feedback on SB 375 travel reduction goals and provide technical assistance and grant writing assistance to help sub areas of the County that need it most. This is an annual process reviewed by the TTAC and RPAC.

# **DISCUSSION**:

A new 2-part strategy was proposed in the 2014 RTP/SCS, and continued in subsequent cycles, to help our member agencies voluntarily monitor their progress toward the region's air emission goals. The strategy also helps member agencies develop projects that will better compete for funding under policies that emphasizes sustainability. Kern COG provides monitoring data along with technical assistance and grant writing assistance. The data provides sub-regional monitoring feedback and helps prioritize assistance using the regional travel model as part of this process.

## **COG Technical Assistance**

The 2014 RTP was the first to contain an SCS as required by the state Climate Protection Act of 2008 (SB 375). Kern COG began work with member agencies on developing more sustainable projects and strategies immediately after the adoption of the 2008 Kern Regional Blueprint.

Since 2009, Kern COG has awarded over \$500,000 in technical assistance grants and/or staff time support to provide member agencies with resources to identify and implement projects that would further the goals of the 2008 Kern Regional Blueprint and now the SCS. Available funding for Kern COG technical assistance grants, and staff time support to assist member agencies in applying for the numerous grant resources varies from year to year based on need and resource availability. This program has helped fund:

- In kind staff-time match for sustainable community planning grants for modeling/public outreach
- Regional travel demand modeling and GIS mapping support
- community bike and complete street plans
- community visioning/design workshops
- 2D/3D community visualizations

- transportation impact fee programs
- general plan circulation element updates
- Early transportation project development planning studies

Member Agencies Email Sustainable Community Planning/Project Development Ideas to Kern COG by Friday, September 29, 2023 - Under this Kern COG local government assistance program, staff can recommend that technical assistance resources be prioritized for agencies with the greatest potential need (see monitoring section below). Agencies must request technical assistance in writing by September 29, 2023 for consideration. Requests may be made by email and should include a brief preliminary scope and budget regarding the planning level work needed. Agencies are encouraged to contact COG staff for assistance in developing the request for sustainable community strategy implementation and planning funds. Staff will provide assistance to member agencies in deciding which grant resources (see attachment 1) are most appropriate and effective. The program allows users to tailor their grant searches to their needs. To receive access, the member agency may designate up to two users on the attached form and return it to Linda Urata, Regional Planner. Currently all member agencies have access except for the cities of Shafter and Tehachapi. **Prioritized Funding Policy for More Sustainable Projects** - In November 2012 and most recently updated in April 2021, the Kern COG Board adopted the new project delivery policies and procedure (<a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>) to assist the region in promoting projects that better match the goals of the RTP/SCS. Dependent on the funding category, the procedure provides points for ranking projects for future funding. Up to half of the points go to projects that promote more sustainable/livable communities and lower air emissions. Since this policy and procedure update, Kern COG has funded park & ride facilities in California City and South Bakersfield, the Golden Empire Transit District has implemented a new/more convenient bus rapid transit, express bus and On Demand microtransit network, and the City of Tehachapi has adopted the first city-wide "form-based-code" General Plan in California. These types of projects are proliferating in the region in part because of the Kern COG adopted project delivery policies.

## **Monitoring Data Feedback**

The table in Attachment 2 shows the latest modeling of auto Vehicle Miles Traveled (VMT) per person (household population + employment by place of work) from the most recently adopted RTP. The total shows a 2.6 percent decrease in VMT between 2020 and 2022. All regions show lower VMT per capita household population + employment by 2046 compared to 2020 except for Greater Taft, Arvin and Tehachapi.

This technical and grant writing assistance program RTP strategy will continue to be funded as planning funds and grants are available. Subject to the Board's direction, Kern COG resources may be prioritized to communities that may be showing difficulty in making progress towards reducing emissions and passenger vehicle travel. Grants and incentives are subject to state and federal funding requirements.





Note that this reporting is voluntary and for advisory purposes only. Future year values are estimated based on the latest land use assumptions and are updated every four years. These assumptions can vary widely from year to year based on recent changes in the local development activity and other variables. Although average travel per person includes areas outside each sub area (see spider diagram maps below), they do not include travel outside the county, possibly skewing the results of sub areas nearer the edge of the County. The analysis shows that Bakersfield and Ridgecrest have the lowest travel per person possibly because these regions are fairly self-contained having sufficient amenities such as hospitals. The 2022 RTP/SCS is the first to be accepted in the San Joaquin Valley by the California Aire Resources Board and demonstrates that Kern is on track to make state GHG targets for passenger vehicle travel if fully implemented.




#### Transportation Analysis Zones (TAZs) by Regional Statistical Areas (RSAs)







UPDATE: SB 375 GREENHOUSE GAS EMISSION REDUCTION FROM PASSENGER VEHICLES AND ADOPTION TIMELINE FOR THE 2026 RTP

#### **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets. This item was shared with the Regional Planning Advisory Committee.

#### **DISCUSSION:**

This discussion provides an update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

August 10, 2023 - California Air Resources Board (ARB) staff announced at the quarterly San Joaquin Valley Inter-Agency Consultation meeting that Kern, Stanislaus, and Tulare COGs have received their approval and will receive official documentation in September. Fresno and San Joaquin COGs have completed their reviews and are in the process of making some required board actions before they can receive their official approval. Kings, Madera and Merced are still under review by ARB staff.

July 26, 2023 – 2026 RTP/SCS Roundtable Meeting was held for environmental, equity, business & industry groups on the public outreach process at Kern COG and included 14 representatives from the Delores Huerta Foundation, Central California Asthma Collaborative, Sierra Club, Home Builders Association, Golden Empire Transit, Caltrans, County Public Works, and staff from the cities of McFarland, Taft, and Wasco.

July 13, 2023 - ARB staff emailed Kern COG and the California, the final acceptance letter is still working its way through upper management reviews and may not be issued till September due to staffing and vacation issues.

June 15, 2023 – Kern COG Board approved the 2023 Public Involvement Procedures document after a 45-day public review. The document is online at <a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>.

June 13, 2023 – ARB staff emailed Kern COG and the California Transportation Commission that "the SCS is officially approved." However, the final acceptance letter is still working its way through upper management reviews and will take several weeks before it is issued.

May 19, 2023 – ARB staff acknowledged receipt of the requested transmittal letter signed by the Kern COG Chair, and associated TPPC staff report. ARB staff indicated they would provide a status update by May 31, and try to meet Kern COG's request for an expedited review by June 8, but that they could not commit to any date earlier than June 27.

May 5, 2023 - Kern COG submitted a draft of a Kern COG TPPC staff report and transmittal letter to ARB with a request for the Kern COG Chair to sign. The item was approved by the Board on May 18, 2023 and signed by the Chair. The letter documents technical changes that do not affect the adopted RTP/SCS text or conclusions. The document contains updates from the November 2022 SCS technical data submittal to ARB consistent with ARB guidelines.

May 1, 2023 – Kern COG circulated the draft Public Involvement Procedure for 45-day public review period to be concluded on June 15. In addition, the Kern COG Executive Director and other COG directors from the San Joaquin Valley met with the SJV representative on the California Air Resources Board. At that meeting ARB staff indicated that Kern was close to receiving the acceptance finding for their SCS.

April 26, 2023 – Kern COG submitted to ARB a cover letter and revised technical methodology data submittal with all the requested updates since the November data submittal. ARB requested that the Kern COG's chair's signature be approved by the Kern COG Board,

April 17, 2023 – Kern COG web conferenced with ARB staff for the 14<sup>th</sup> time in 3 years to discuss the 2022 SCS technical methodology. One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memorandum. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18, 2023. ARB is required to provide their finding and recommendations 2 months after the submitted package from Nov. 29, 2023 is found complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the ARB January 20, 2023 questions on Kern COG's technical methodology package provided to ARB on November 29, 2023.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A meeting was held on January 24, 2023 to clarify questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range transportation program air quality conformity was federally approved. The 2023 FTIP "CTIPS Report" and "Grouped Project Listing" weblinks are available at: <a href="https://www.kerncog.org/2023-ftip/">https://www.kerncog.org/2023-ftip/</a>.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available on the Kern COG website at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

#### **DESCRIPTION:**

The 2022 Regional Transportation Plan (RTP)/Sustainable Communities Strategy (SCS) includes a strategy to provide sub regional feedback on SB 375 travel reduction goals and provide technical assistance and grant writing assistance to help sub areas of the County that need it most. This is an annual process reviewed by the TTAC and RPAC.

#### **DISCUSSION**:

A new 2-part strategy was proposed in the 2014 RTP/SCS, and continued in subsequent cycles, to help our member agencies voluntarily monitor their progress toward the region's air emission goals. The strategy also helps member agencies develop projects that will better compete for funding under policies that emphasizes sustainability. Kern COG provides monitoring data along with technical assistance and grant writing assistance. The data provides sub-regional monitoring feedback and helps prioritize assistance using the regional travel model as part of this process.

#### **COG Technical Assistance**

The 2014 RTP was the first to contain an SCS as required by the state Climate Protection Act of 2008 (SB 375). Kern COG began work with member agencies on developing more sustainable projects and strategies immediately after the adoption of the 2008 Kern Regional Blueprint.

Since 2009, Kern COG has awarded over \$500,000 in technical assistance grants and/or staff time support to provide member agencies with resources to identify and implement projects that would further the goals of the 2008 Kern Regional Blueprint and now the SCS. Available funding for Kern COG technical assistance grants, and staff time support to assist member agencies in applying for the numerous grant resources varies from year to year based on need and resource availability. This program has helped fund:

- In kind staff-time match for sustainable community planning grants for modeling/public outreach
- · Regional travel demand modeling and GIS mapping support
- community bike and complete street plans
- community visioning/design workshops
- 2D/3D community visualizations

- transportation impact fee programs
- general plan circulation element updates
- Early transportation project development planning studies

**Prioritized Funding Policy for More Sustainable Projects** - In November 2012 and most recently updated in April 2021, the Kern COG Board adopted the new project delivery policies and procedure (<a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>) to assist the region in promoting projects that better match the goals of the RTP/SCS. Dependent on the funding category, the procedure provides points for ranking projects for future funding. Up to half of the points go to projects that promote more sustainable/livable communities and lower air emissions. Since this policy and procedure update, Kern COG has funded park & ride facilities in California City and South Bakersfield, the Golden Empire Transit District has implemented a new/more convenient bus rapid transit, express bus and On Demand microtransit network, and the City of Tehachapi has adopted the first city-wide "form-based-code" General Plan in California. These types of projects are proliferating in the region in part because of the Kern COG adopted project delivery policies.

#### **Monitoring Data Feedback**

The table in Attachment 2 shows the latest modeling of auto Vehicle Miles Traveled (VMT) per person (household population + employment by place of work) from the most recently adopted RTP. The total shows a 2.6 percent decrease in VMT between 2020 and 2022. All regions show lower VMT per capita household population + employment by 2046 compared to 2020 except for Greater Taft, Arvin and Tehachapi.

This technical and grant writing assistance program RTP strategy will continue to be funded as planning funds and grants are available. Subject to the Board's direction, Kern COG resources may be prioritized to communities that may be showing difficulty in making progress towards reducing emissions and passenger vehicle travel. Grants and incentives are subject to state and federal funding requirements.





Note that this reporting is voluntary and for advisory purposes only. Future year values are estimated based on the latest land use assumptions and are updated every four years. These assumptions can vary widely from year to year based on recent changes in the local development activity and other variables. Although average travel per person includes areas outside each sub area (see spider diagram maps below), they do not include travel outside the county, possibly skewing the results of sub areas nearer the edge of the County. The analysis shows that Bakersfield and Ridgecrest have the lowest travel per person possibly because these regions are fairly self-contained having sufficient amenities such as hospitals. The 2022 RTP/SCS is the first to be accepted in the San Joaquin Valley by the California Aire Resources Board and demonstrates that Kern is on track to make state GHG targets for passenger vehicle travel if fully implemented.




#### Transportation Analysis Zones (TAZs) by Regional Statistical Areas (RSAs)







REGIONAL EARLY ACTION PLANNING GRANT PROGRAM (REAP) FUNDING

#### **DESCRIPTION:**

Kern Council of Governments (COG) will soon be receiving an additional allocation of Regional Early Action Planning (REAP). The amount to be allocated at this time to Kern COG is \$924,200.

#### **DISCUSSION:**

On March 31, 2021, the Regional Planning Advisory Committee (RPAC) voted to recommend to the Kern COG Board Sub-Allocation of the first round of REAP funding. As the RPAC will recall, the sub-allocation was done by population with a minimum funding of \$10,000. Attached as information is Exhibit A delineating the amounts allocated for each member agency in 2021.

During past meetings, the RPAC has discussed the new requirements for Housing Elements including a program that Affirmatively Furthers Fair Housing (AFFH) and promotes housing opportunities throughout the community for protected classes, conducting an assessment of Fair Housing, preparing a Land Inventory and identification of sties through the lens of AFFH, and required CEQA reviews for small to medium sized cities. Consensus from public sector planners is that it will take \$200,000 to \$500,000 to complete housing elements even in small and medium sized cities. With the upcoming additional allocation of \$924,200 Kern COG staff is recommending the following:

- 1. Kern COG be allocated 5% of the funding for administrative tasks,
- 2. The remainder of the funds be allocated equally among the member agencies.

Attached for your review is Exhibit B depicting staff's recommendation.

#### **Uses of REAP Sub-Allocation funds require:**

- Funds must be used for housing planning activities.
- Activities must demonstrate a nexus to increasing housing and accelerating housing production.

- Eligible activities under Sub-allocations may be coordinated or combined with LEAP pursuant to Health and Safety Code section 50515.03.
- Eligible activities under Sub-allocations may be used to establish Pro-housing Policies pursuant to Government Code section 65589.9.
- Sub-allocation for housing-related planning activities shall include but are not limited to:
  - Technical assistance in improving housing permitting processes, tracking systems, and planning tools.
  - Establishing regional or countywide housing trust funds for affordable housing (e.g., planning activities and processes, guidelines, charters).
  - Performing infrastructure planning, including sewers, water systems, transit, roads, or other public facilities necessary to support new housing and new residents.
  - Performing feasibility studies to determine the most efficient locations to site housing consistent with Government Code sections 65040.1 (State Planning Priorities) and 65080 (regional transportation plans).
  - Covering the costs of temporary staffing or consultant needs associated with eligible activities.
  - Providing jurisdictions and other local agencies with technical assistance, planning, temporary staffing, or consultant needs associated with updating local planning and zoning documents, expediting application processing, and other actions to accelerate additional housing production.

#### **ACTION:**

- 1. Request the Kern COG Board approve the sub-allocation of \$924,200 in REAP funding as depicted in Exhibit B (Roll Call Vote); or
- 2. Provide staff direction.

UPDATE: SB 375 GREENHOUSE GAS EMISSION REDUCTION FROM PASSENGER VEHICLES AND ADOPTION TIMELINE FOR THE 2026 RTP

#### **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets.

#### DISCUSSION:

This discussion provides an update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

September 21, 2023 – California Air Resources Board (ARB) provided an email update on the status of Kern COG's promised 2022 RTP/SCS acceptance letter. A key upper management review person is not available this month pushing the issuance of the final letter into October 2023, 4-months after ARB indicated acceptance of Kern COG's SCS in their June 13<sup>th</sup> email.

August 10, 2023 - ARB staff announced at the quarterly San Joaquin Valley Inter-Agency Consultation meeting that Kern, Stanislaus, and Tulare COGs have received their approval and will receive official documentation in September. Fresno and San Joaquin COGs have completed their reviews and are in the process of making some required board actions before they can receive their official approval. Kings, Madera, and Merced are still under review by ARB staff.

July 26, 2023 – 2026 RTP/SCS Roundtable Meeting was held for environmental, equity, business & industry groups on the public outreach process at Kern COG and included 14 representatives from the Delores Huerta Foundation, Central California Asthma Collaborative, Sierra Club, Home

Builders Association, Golden Empire Transit, Caltrans, County Public Works, and staff from the cities of McFarland, Taft, and Wasco.

July 13, 2023 - ARB staff emailed Kern COG and the California, the final acceptance letter is still working its way through upper management reviews and may not be issued till September due to staffing and vacation issues.

June 15, 2023 – Kern COG Board approved the 2023 Public Involvement Procedures document after a 45-day public review. The document is online at <a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>.

June 13, 2023 – ARB staff emailed Kern COG and the California Transportation Commission that "the SCS is officially approved." However, the final acceptance letter is still working its way through upper management reviews and will take several weeks before it is issued.

May 19, 2023 – ARB staff acknowledged receipt of the requested transmittal letter signed by the Kern COG Chair, and associated TPPC staff report. ARB staff indicated they would provide a status update by May 31, and try to meet Kern COG's request for an expedited review by June 8, but that they could not commit to any date earlier than June 27.

May 5, 2023 - Kern COG submitted a draft of a Kern COG TPPC staff report and transmittal letter to ARB with a request for the Kern COG Chair to sign. The item was approved by the Board on May 18, 2023, and signed by the Chair. The letter documents technical changes that do not affect the adopted RTP/SCS text or conclusions. The document contains updates from the November 2022 SCS technical data submittal to ARB consistent with ARB guidelines.

May 1, 2023 – Kern COG circulated the draft Public Involvement Procedure for 45-day public review period to be concluded on June 15. In addition, the Kern COG Executive Director and other COG directors from the San Joaquin Valley met with the SJV representative on the California Air Resources Board. At that meeting ARB staff indicated that Kern was close to receiving the acceptance finding for their SCS.

April 26, 2023 – Kern COG submitted to ARB a cover letter and revised technical methodology data submittal with all the requested updates since the November data submittal. ARB requested that the Kern COG's chair's signature be approved by the Kern COG Board,

April 17, 2023 – Kern COG web conferenced with ARB staff for the 14<sup>th</sup> time in 3 years to discuss the 2022 SCS technical methodology. One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memorandum. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18, 2023. ARB is required to provide their findings and recommendations 2 months after the submitted package from Nov. 29, 2023, is found complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the ARB January 20, 2023 questions.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A meeting was held on January 24, 2023, to clarify questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range transportation program air quality conformity was federally approved.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available on the Kern COG website at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

#### **DESCRIPTION:**

Timeline for development of the Kern Regional Growth Forecast for 2024-2050.

#### DISCUSSION:

Kern COG's regional growth forecast is essential to many of Kern COG's planning efforts. The 2017 California Regional Transportation Plan (RTP) Guidelines prepared pursuant to Government Code, §14522, list the third step to be undertaken in the development of the RTP as follows: "Forecasting future population and employment growth". Updating the regional growth forecast is a critical step in moving forward with the preparation of Kern COG's next RTP.

The regional growth forecast is also referenced by Kern COG's member agencies for a variety of planning related tasks, such as: environmental impact analysis/reports, transportation models/impacts, assessing impact fees, determining need for services/infrastructure/utilities, and numerous planning studies.

Kern COG solicited proposals and advertised a request for proposal for the update to Kern COG's growth forecast. The consultant reviewing team was made up of staff from both the cities of Arvin and Shafter, Kern Economic Development Corporation (KEDC) along with Kern COG staff. The team selected PlaceWorks from the submitted proposals.

As a part of the contract PlaceWorks will also be doing subarea forecasts within the 12 Regional Statistical Areas Kern COG uses in its modeling efforts.

The consultant contract is anticipated to be on the Kern COG Board agenda on October 19<sup>th</sup>. The project will kick-off in October 2023 and is anticipated to be completed by March 31<sup>st</sup>, 2024. A project kick-off meeting is tentatively scheduled for the week of October 23<sup>rd</sup>, 2023. UPDATE: SB 375 GREENHOUSE GAS EMISSION REDUCTION FROM PASSENGER VEHICLES AND ADOPTION TIMELINE FOR THE 2026 RTP

#### **DESCRIPTION:**

The Regional Transportation Plan (RTP) is required to be updated every 4-years and contains a long range 24-year transportation expenditure portfolio fulfilling numerous policies and regulations including but not limited to public involvement, social equity, air quality conformity, congestion management, and Senate Bill (SB) 375 per capita greenhouse gas (GHG) reduction targets. This standing item is regularly reviewed by the Regional Planning Advisory Committee.

#### **DISCUSSION:**

This discussion provides an update on the activity related to the RTP and the SB 375 Sustainable Communities Strategy (SCS). The report is updated regularly with the most recent developments listed first.

October 18, 2023 – California Air Resources Board (ARB) provided an email update on the status of Kern COG's promised 2022 RTP/SCS acceptance letter. A key upper management review person is not available this month pushing the issuance of the final letter into November 2023, 5-months after ARB indicated acceptance of Kern COG's SCS in their June 13<sup>th</sup> email.

August 10, 2023 - ARB staff announced at the quarterly San Joaquin Valley Inter-Agency Consultation meeting that Kern, Stanislaus, and Tulare COGs have received their approval and will receive official documentation in September. Fresno and San Joaquin COGs have completed their reviews and are in the process of making some required board actions before they can receive their official approval. Kings, Madera, and Merced are still under review by ARB staff.

July 26, 2023 – 2026 RTP/SCS Roundtable Meeting was held for environmental, equity, business & industry groups on the public outreach process at Kern COG and included 14 representatives

from the Delores Huerta Foundation, Central California Asthma Collaborative, Sierra Club, Home Builders Association, Golden Empire Transit, Caltrans, County Public Works, and staff from the cities of McFarland, Taft, and Wasco.

July 13, 2023 - ARB staff emailed Kern COG and the California, the final acceptance letter is still working its way through upper management reviews and may not be issued till September due to staffing and vacation issues.

June 15, 2023 – Kern COG Board approved the 2023 Public Involvement Procedures document after a 45-day public review. The document is online at <a href="https://www.kerncog.org/policies/">https://www.kerncog.org/policies/</a>.

June 13, 2023 – ARB staff emailed Kern COG and the California Transportation Commission that "the SCS is officially approved." However, the final acceptance letter is still working its way through upper management reviews and will take several weeks before it is issued.

May 19, 2023 – ARB staff acknowledged receipt of the requested transmittal letter signed by the Kern COG Chair, and associated TPPC staff report. ARB staff indicated they would provide a status update by May 31, and try to meet Kern COG's request for an expedited review by June 8, but that they could not commit to any date earlier than June 27.

May 5, 2023 - Kern COG submitted a draft of a Kern COG TPPC staff report and transmittal letter to ARB with a request for the Kern COG Chair to sign. The item was approved by the Board on May 18, 2023, and signed by the Chair. The letter documents technical changes that do not affect the adopted RTP/SCS text or conclusions. The document contains updates from the November 2022 SCS technical data submittal to ARB consistent with ARB guidelines.

May 1, 2023 – Kern COG circulated the draft Public Involvement Procedure for 45-day public review period to be concluded on June 15. In addition, the Kern COG Executive Director and other COG directors from the San Joaquin Valley met with the SJV representative on the California Air Resources Board. At that meeting ARB staff indicated that Kern was close to receiving the acceptance finding for their SCS.

April 26, 2023 – Kern COG submitted to ARB a cover letter and revised technical methodology data submittal with all the requested updates since the November data submittal. ARB requested that the Kern COG's chair's signature be approved by the Kern COG Board,

April 17, 2023 – Kern COG web conferenced with ARB staff for the 14<sup>th</sup> time in 3 years to discuss the 2022 SCS technical methodology. One final methodology issue remains out of 27 identified in CARB's January 20<sup>th</sup> memorandum. Additional adjustments were made to the elasticity used to adjust the hybrid NCST tool method used by Fresno COG. Documentation of the adjustment was submitted to ARB on April 18, 2023. ARB is required to provide their findings and recommendations 2 months after the submitted package from Nov. 29, 2023, is found complete.

March 29, April 7, April 14, 2023 – Kern COG web conferenced with ARB to further refine SCS modeling methodology.

February 17, 2023 – Kern COG submitted responses to the ARB January 20, 2023 questions.

January 20, 2023 – ARB responded to Kern COGs SCS technical methodology submittal from November 29, 2022 with questions. A meeting was held on January 24, 2023, to clarify questions.

December 16, 2022 – The 2022 RTP/Federal Transportation Improvement Program (FTIP) short range transportation program air quality conformity was federally approved.

November 29, 2022 – Kern COG submitted the technical methodology data package to the ARB.

July 21, 2022 - the Kern COG Board adopted the 2022 RTP/SCS and associated documents. The documents are available on the Kern COG website at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

March 22, 2018 - ARB adopted new SB375 Targets for the third cycle RTP/SCS to be effective October 1, 2018. Next ARB target setting will be during the 2022-2026 window.

June 13, 2017 - ARB released proposed targets that were 2 percentage points higher than what Kern COG recommended for 2035. The related ARB documents are available online at https://www.arb.ca.gov/cc/sb375/sb375.htm . Kern COG's April target recommendation letter is located B-143 of ARB staff on the report page https://www.arb.ca.gov/cc/sb375/appendix b mpo scenario and data submittals.pdf . Kern COG and the 8 San Joaquin Valley COG's prepared individual letters and a joint comment letter. The letters document methodological changes that make it difficult to compare the 2014 RTP results with the latest modeling refinements.
