Traffic will be reduced to 1 lane on the westbound direction.

This project proposes to remove the damaged bridge barrier and replace it with a Caltrans Standard barrier. This project was initiated due to a vehicle accident that took out most of the existing barrier in late July 2025. The Director's Order is still pending approval and DES Design is still working on design of the new barrier.

• Stakeholder and local partner review of the draft concluded last week on the 12<sup>th</sup>, we are still on track to deliver the final CMCP by the end of the month.

#### 06-1F5901 Wasco 46 Pedestrian Beacon

At Highway 46 and Poplar the project will install a "HAWK" pedestrian hybrid beacon system, traffic signs, and restripe pavement markings at the uncontrolled intersection to enhance pedestrian safety.

Coop executed April 28, 2025.

Permit issued July 21, 2025. The Project is set for Council approval to award on October 21st.

Construction anticipated to start by early to mid November.

#### 06-1F601 Wasco 43 Pedestrian Beacon

At the intersection of State Route 43 and 8<sup>th</sup> Street in Wasco the project proposes to install Rectangular Rapid-Flashing Beacon (RRFB), bulb-outs, ADA compliant ramps, Advance STOP or YIELD markings and traffic signs, crosswalk visibility enhancements, stripe and pavement markings.

This is an oversight project for the City of Wasco.

Caltrans is contributing 60K to the project. Encroachment Permit Project - Permit was granted and issued on 5/14/25. The city anticipates starting construction by November.

Reminder - Utility relocations began this summer. Project Construction scheduled to be Awarded in early 2026, but it will have a delayed start to coordinate with Railroad and Utility relocations.

PM, Shelley Maggard gave a project presentation to the Wasco City Council at June 3<sup>rd</sup> meeting. Shelley is coordinating with Wasco City manager to schedule another presentation after the first of the year (2026), preferably once contractor is on board.

The proposed SB SR 99 to WB SR 58 Connector Project is situated within Kern County, Bakersfield, California. This project entails the construction of a direct freeway to freeway connector for SB SR 99 to WB SR 58. Environmental revalidation was approved on Sep 29<sup>th</sup>. The supplemental PR was approved on Oct 17<sup>th</sup>. The Baseline agreement package was approved at the December CTC 2023 meeting.

The latest Construction Capital estimate is \$47M.

PSE progressing. 60% PSE Constructability review meeting completed on September 30, 2025.

Submitting the baseline agreement week of 10/13 to HQ for the Dec CTC.

The team is looking into accommodating a future northbound auxiliary lane and hardscaping.

- Railroad work will include a cantilever structure, lighting and sidewalks at the tracks to meet UPRR requirements.

In PS&E phase. Target Design completion (RTL) is October 2025. Project requires permits from Federal Lands Bureau of Reclamation with an anticipated delay in construction until March 2027.

The project proposes to rehabilitate the existing bridge by retrofitting the bridge and fortifying the column support system that is currently sinking. It is anticipated that the

bridge would need to be shut down to traffic for 90 days during construction in mid-2025.

Project achieved RTL Date: 1/29/2024

Contract was awarded to Granite Construction. There had a delayed due to encroachment permit requirement with Department of Water Resources. State Route 166 will be closed starting September 22, 2025 with a detour in place for approximately 75-calendar days to complete the rehabilitation activities. The majority of the work is anticipated to be completed by the end of the year 2025. The construction acceptance is anticipated to be achieved by summer of 2026.

Rehab travel lanes with CRCP pavement. In Bakersfield from 0.1 mile north of White Lane OC to California Avenue UC.

The project scope has been expanded to include the SB Aux Lane and Palm Street Bridge replacement, and California Bridge widening to be paid for by the SHOPP. Project is currently at the end of the PA&ED phase.

PGE completed their work in last month. Construction is working on punchlist.

This project proposes to rehabilitate and bring to current standards the existing roadway on State Route (SR) 184, in Kern County, between approximately Wharton Ave and Edison Highway – postmile (PM)1.1 to 8.3. The roadway will be rehabilitated and Complete Streets elements, including (ADA) compliant sidewalks and curb ramps, bus stops, and continuous bike lanes in both directions will be incorporated within the project limits. Drainage improvements, traffic signal system upgrades, and median worm curbs are proposed to be included in this project.

The project completed design in December 2024. Project was awarded to Griffith Construction in August 2025. The project has a 6-month delayed start. The current target start of construction is by end of spring 2026.

WHEREAS, claimant's claim, submitted and on file as part of the official Kern COG records, is made a part of this resolution by this reference.

#### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. This allocation is made for the fiscal year 2024-25 to the claimant listed above and in accordance with Schedule A, attached hereto and made a part of this resolution by this reference; and
- 2. Kern COG hereby makes the following findings:
  - a) Claimant's proposed transit services are responding to transit needs currently not being met in the area of apportionment; and
  - b) Claimant's proposed transit services shall, if appropriate, be integrated with existing transit services; and
  - c) Claimant's proposed budget, as itemized in the claim, designate revenues and expenses conforming with the RTP; and
  - d) The ratio of fare revenue to operating costs is sufficient to enable claimant to meet the requirements of California Public Utilities Code Sections 99268.2, 99268.3, 99268.4, 99268.5, 99268.6, 99268.7, 99268.9, 99268.11, 99268.12, 99268.26, 99268.17, and 99268.19, as applicable; and
  - e) Claimant has made full use of federal funds available under the Urban Mass Transportation Act of 1964, as amended; and
  - f) The sum of claimant's allocation from the Local Transportation Fund and State Transit Assistance Fund does not exceed the amount eligible to be received during the fiscal year. Claimant may, however, be required to repay excess funds, pursuant to Title 21 California Code of Regulations Section 6735; and

- g) Kern COG has considered claims to offset unanticipated increases in fuel costs, to enhance existing transit services, to meet high priority regional sub-regional transit needs; and
- h) Claimant has made reasonable efforts to implement the productivity improvements developed pursuant to PUC section 99244; and
- i) Claimant is not precluded by contract from employing part-time drivers or from contracting with common carriers operating under franchise or license; and
- j) Claimant has received certification by the California Highway Patrol within the last thirteen months indicating that the operations are in compliance with California Vehicle Code Section 1808.1.
- 3. Claimant is allocated Local Transportation Fund and State Transit Assistance fund monies in amounts not to exceed that listed on Schedule A, attached hereto and made a part of this resolution by this reference; and
- 4. Disbursement of transit monies, allocated for the regional planning process, shall be made from claimant's Local Transportation Fund reserve accounts to the Kern COG planning account as the first priority payment; and
- 5. Disbursement of claimant's remaining transit allocation to its local treasury shall be made as the second priority payment in mutually agreed installments; and
- 6. The Kern County Auditor-Controller is authorized to make disbursements of Local Transportation fund monies as they become available and in accordance with written Kern COG instructions; and
- 7. The Kern COG Executive Director is authorized to transmit a copy of this resolution to the Kern County Auditor-Controller in support of disbursements.

#### **DESCRIPTION:**

Every two years, regional agencies submit a Regional Transportation Improvement Program (RTIP) by December 15th to the California Transportation Commission for their approval. The Transportation Technical Advisory Committee has reviewed this item.

#### **DISCUSSION:**

The California Transportation Commission (CTC) initiated the 2026 Regional Transportation Improvement Program (RTIP) process at their January 30 – 31, 2025 meeting to develop the 2026 State Transportation Improvement Program (STIP) for projects of regional significance. The process includes: 1) CTC development of a statewide 5-Year regional share fund estimate; 2) CTC update of STIP guidelines; 3) Regional submittal of RTIP's; and 4) CTC consolidation of RTIP's for approval of the 2026 STIP.

- 1. SR 58 Truck Climbing Lane Phase 2 "PM 71.8-74.9" was added to the project description; \$25.371 RIP funding previously showing in FY 29/30 alone is now split between FY 29/30 and FY 30/31.
- 2. The funding shown in the "Total for 2026 RTIP Submittal" row was corrected.

WHEREAS, pursuant to State law, every two years Kern COG is required to develop and submit to the California Transportation Commission (CTC) a Regional Transportation Improvement Program (RTIP) that identifies projects to be included in the State Transportation Improvement Program (STIP); and

WHEREAS, Kern COG has prepared the 2026 RTIP in compliance with CTC adopted 2026 STIP Guidelines and the 2026 STIP Fund Estimate; and

WHEREAS, the projects contained in the 2026 RTIP are consistent with Kern COG's adopted 2022 Regional Transportation Plan (RTP), 2025 Federal Transportation Improvement Program (FTIP), and

WHEREAS, the 2026 RTIP has been developed in coordination with technical and project management staff representing Kern COG's member agencies, as well as the Kern COG Transportation Planning Policy Committee (TPPC) and Caltrans; and

WHEREAS, the 2026 RTIP proposes \$26,371,000 in new programming of Regional Improvement Program funds into the 2026 STIP cycle for Federal Fiscal Years 2026-27 through 2030-31 in addition to carry-over programming for projects currently programmed in the 2024 STIP that have not yet been allocated; and

#### **DESCRIPTION:**

The California Department of Transportation (Caltrans) has approved \$300,000 in its fiscal year 2025-26 budget and is part of the state approved 2024 State Transportation Improvement Program to fund Kern COG's Planning, Programming and Monitoring (PPM) activity.

#### **DISCUSSION:**

Pursuant to Kern Council of Governments (Kern COG) policy, the Kern COG Board of Directors shall review and approve grant funding agreements. The California Department of Transportation (Caltrans) has approved \$300,000 in its fiscal year 2025-26 budget and is part of the state approved 2024 State Transportation Improvement Program to fund Kern COG's Planning, Programming and Monitoring activity. This funding supports the management, development, and implementation of regional projects countywide.

The attached Fund Transfer Agreement allows Kern COG to receive funding for Planning, Programming, and Monitoring of transportation development activities as identified in Kern COG's Overall Work Program for 2025-26. This item received an allocation vote for \$300,000 by the California Transportation Commission at their October 16-17, 2025 meeting authorizing Kern COG to use this funding. Staff recommends approval of the Fund Transfer Agreement No. PPM26-6087(085).

THIS AGREEMENT, effective on October 17, 2025 is between the State of California, acting by and through the Department of Transportation, hereinafter referred to as STATE, and Kern County Council of Governments, a local public agency, hereinafter referred to as ADMINISTERING AGENCY.

WHEREAS the annual California State Budget Act appropriates State Highway funds under local assistance for the State Transportation Improvement Program (STIP) Planning, Programming and Monitoring Program (PPM), and

WHEREAS PPM is defined as the project planning, programming and monitoring activities related to development of the Regional Transportation Improvement Program and the STIP required by Government Code Section 14527, et. seq. and for the monitoring of project implementation for projects approved in these documents, hereinafter referred to as PPM PROJECT, and

WHEREAS the California Transportation Commission (CTC) is tasked to allocate these funds in accordance with the amounts approved in the STIP in accordance with section 14527 (h) of the California Government code:

NOW, THEREFORE, the parties agree as follows:

#### SECTION I

#### STATE AGREES:

1. As authorized by Section 14527(h) of the Government Code to release to the ADMINISTERING AGENCY for its PPM PROJECT in an amount not to exceed \$300,000.00 from monies appropriated for the PPM Program as follows:

- 2. To pay the ADMINISTERING AGENCY a single lump sum payment upon final execution of this AGREMENT and the receipt of an original and two copies of a signed initial invoice in the proper form from ADMINISTERING AGENCY in the amount shown in Section 1, Article (1) as promptly as state fiscal procedures will permit.
- 3. When conducting an audit of the costs claimed under the provisions of this Agreement, to rely to the maximum extent possible on any prior audit of ADMINISTERING AGENCY pursuant to the provisions of State and federal laws. In the absence of such an audit, work of other auditors will be relied upon to the extent that work is acceptable to STATE when planning and conducting additional audits.

#### SECTION II

#### ADMINISTERING AGENCY AGREES:

- 1. To use all state funds paid hereunder only for eligible PPM specific work activities as defined in Attachment A to this AGREEMENT.
- 2. To use all state funds paid hereunder only for those transportation purposes that conform to Article XIX of the California State Constitution.
- 3. To prepare and submit to STATE an original and two copies of signed invoice for payment.
- 4. To prepare a Final Project Expenditure Report including a final invoice reporting actual costs expended in accordance with Attachment A and submit that Report and invoice no later than 60 days following the completion of expenditures. These allocated PPM funds are available for expenditure until June 30, 2028. The Final Report of Expenditures must state that the PPM funds were used in conformance with Article XIX of the California State Constitution and for PPM purposes as defined in this Agreement. Three copies of this report shall be submitted to STATE.

#### 5. COST PRINCIPLES

- A) To comply with, and require all project sponsors to comply with Office of Management and Budget Supercircular 2 CFR 200, Cost Principles for State and Local Government, and the Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments.
- B) ADMINISTERING AGENCY will assure that its Fund recipients will be obligated to agree that (a) Contract Cost Principles and Procedures, 48 CFR, Federal Acquisition Regulations System, Chapter 1, Part 31, et seq., shall be used to determine the allowability of individual Project cost items and (b) those parties shall comply with Federal administrative procedures in accordance with 2 CFR 200, Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments. Every sub-recipient receiving Funds as a contractor or sub-contractor under this Agreement shall comply with Federal administrative procedures in accordance with 2 CFR 200, Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments.

C) Any Fund expenditures for costs for which ADMINISTERING AGENCY has received payment or credit that are determined by subsequent audit to be unallowable under Office of Management and Budget Supercircular 2 CFR 200, are subject to repayment by ADMINISTERING AGENCY to STATE. Should ADMINISTERING AGENCY fail to reimburse Fund moneys due STATE within 30 days of demand, or within such other period as may be agreed in writing between the Parties hereto, STATE is authorized to intercept and withhold future payments due ADMINISTERING AGENCY from STATE or any third-party source, including, but not limited to, the State Treasurer, the State Controller and the CTC. The implementation of the Supercircular will cancel 49 CFR, Part 18.

#### 6. THIRD PARTY CONTRACTING

- A) ADMINISTERING AGENCY shall not award a construction contract over \$10,000 or other contracts over \$25,000 [excluding professional service contracts of the type which are required to be procured in accordance with Government Code Sections 4525 (d), (e) and (f)] on the basis of a noncompetitive negotiation for work to be performed using Funds without the prior written approval of STATE.
- B) Any subcontract or agreement entered into by ADMINISTERING AGENCY as a result of disbursing Funds received pursuant to this Agreement shall contain all of the fiscal provisions of this Agreement; and shall mandate that travel and per diem reimbursements and third-party contract reimbursements to subcontractors will be allowable as project costs only after those costs are incurred and paid for by the subcontractors.
- C) In addition to the above, the preaward requirements of third party contractor/consultants with ADMINISTERING AGENCY should be consistent with Local Program Procedures as published by STATE.

#### 7. ACCOUNTING SYSTEM

ADMINISTERING AGENCY, its contractors and subcontractors shall establish and maintain an accounting system and records that properly accumulate and segregate Fund expenditures by line item. The accounting system of ADMINISTERING AGENCY, its contractors and all subcontractors shall conform to Generally Accepted Accounting Principles (GAAP), enable the determination of incurred costs at interim points of completion, and provide support for reimbursement payment vouchers or invoices.

#### 8. RIGHT TO AUDIT

For the purpose of determining compliance with this Agreement and other matters connected with the performance of ADMINISTERING AGENCY'S contracts with third parties, ADMINISTERING AGENCY, ADMINISTERING AGENCY's contractors and subcontractors and STATE shall each maintain and make available for inspection all books, documents, papers, accounting records, and other evidence pertaining to the performance of such contracts, including, but not limited to, the costs of administering those various contracts. All of the above referenced parties shall make such materials available at their respective offices at all reasonable times for three years from the date of final payment of Funds to ADMINISTERING AGENCY. STATE, the California State Auditor, or any duly authorized representative of STATE or the United States Department of Transportation, shall each have access to any books, records, and documents that are pertinent for audits, examinations, excerpts, and transactions, and ADMINISTERING AGENCY shall furnish copies thereof if requested.

#### 9. TRAVEL AND SUBSISTENCE

Payments to only ADMINISTERING AGENCY for travel and subsistence expenses of ADMINISTERING AGENCY forces and its subcontractors claimed for reimbursement or applied as local match credit shall not exceed rates authorized to be paid exempt non-represented State employees under current State Department of Personnel Administration (DPA) rules. If the rates invoiced are in excess of those authorized DPA rates, then Administering Agency is responsible for the cost difference and any overpayments shall be reimbursed to STATE on demand.

#### **SECTION III**

#### IT IS MUTUALLY AGREED:

- 1. All obligations of STATE under the terms of this AGREEMENT are subject to the availability of the state funds.
- 2. Eligible expenditures under this AGREEMENT shall be from the effective date of allocation to June 30, 2028.
- 3. In the event that ADMINISTERING AGENCY fails to implement or complete the PPM program commenced under this Agreement, fails to perform any of the obligations created by this agreement or fails to comply with applicable State laws and regulations, STATE reserves the right to terminate funding for the PPM program or portions thereof, upon written notice to ADMINISTERING AGENCY. An audit may be performed as provided in Section II, Article (8) of this agreement.
- 4. Neither STATE nor any officer or employee thereof is responsible for any injury, damage or liability occurring or arising by reason of anything done or omitted to be done by ADMINISTERING AGENCY under or in connection with any work, authority or jurisdiction delegated to ADMINISTERING AGENCY under this Agreement. It is understood and agreed that, pursuant to Government Code Section 895.4, ADMINISTERING AGENCY shall fully defend, indemnify and save harmless the State of California, its officers and employees from all claims, suits or actions of every name, kind and description brought for or on account of injury (as defined in Government Code Section 810.8) occurring by reason of anything done or omitted to be done by ADMINISTERING AGENCY under or in connection with any work, authority or jurisdiction delegated to ADMINISTERING AGENCY under this Agreement.
- 5. As a condition of acceptance of the State funds provided for under this Agreement, ADMINISTERING AGENCY will abide by all State policies and procedures pertaining to the PPM Program.
- 6. This Agreement shall terminate on December 31, 2028.

LONG RANGE TRANSPORTATION PLAN PROJECT LISTING REVISIONS

**SUMMARY** 

#### **DESCRIPTION:**

Development of the 2026 Regional Transportation Plan (RTP) requires the review and update of the RTP Capital Improvement Program (CIP), a 20+ year transportation project listing for the long-range transportation plan available at <a href="https://www.kerncog.org/category/docs/rtp/">https://www.kerncog.org/category/docs/rtp/</a>.

#### **DISCUSSION:**

In November 2023, a draft 2026 CIP transportation project listing was approved by the Transportation Technical Advisory Committee (TTAC) and Transportation Planning Policy Committee (TPPC) for use and development of the draft 2026 RTP development process. Staff is providing some updates to the approved list since 2023 and requesting comments on the updates by November 21, 2025. Updates include some corrections to project dates, costs and incorporation of new near term funded projects. The CIP also includes unfunded projects identified as part of the Kern Area Regional Goods-movement Operations (KARGO) Study.

The 24-year plan covers Kern multi-modal transportation projects from 2026 through 2049. The federally required RTP action element (Ch. 5) includes the CIP divided into two parts: 1) the financially constrained list (Table 5.1) and 2) the financially unconstrained list (Table 5.2). Table 5.1 CIP is more restrictive because these projects are financially constrained based roughly on historic revenue rates. The regionally significant transportation projects—major roadway capacity adding projects—are required to be included in the federal Air Quality Conformity document, the accompanying environmental document, and the numerous accountability performance measures to be provided with the RTP. Improvements in Table 5.2 are not included in these analyses because they are not financially constrained. Regionally significant projects in the short-range 4-year Transportation Improvement Program (TIP) listing are required to be consistent with this RTP CIP project listing. Attached is a portion of Table 5.1 with a listing of regionally significant

projects and associated maps for all the projects in the full project listing. The full project listing is available on Kern COG's website at https://www.kerncog.org/category/docs/rtp/.

As Kern COG staff moves forward with public outreach and for the 2026 RTP, the CIP will continue to be subject to public comments, updates to project listings that have been delivered and other corrections or additions prior to the scheduled circulation of the entire document in Spring of 2026. Please email comments to rball@kerncog.org or call 661-635-2902.

Note that Kern COG staff will try to accommodate changes to this project listing as they arise. However, after the environmental review process begins last minute changes may be deferred to the a future amendment in the next 4-year cycle.

Figure 5-1A: Constrained Projects Countywide





Figure 5-1B: Constrained Projects Metro Bakersfield

Figure 5-23: Kern County Transit, Bike and Highway Projects – Completed/Under Construction 2014-2020





Figure 5-22: Metro Bakersfield Transit, Bike and Highway Projects – Completed/Under Construction 2014-2020

# **DESCRIPTION:**

Non-profit agencies providing transportation services are eligible to apply for funding from the Federal Transit Administration (FTA) through the Section 5310 program. Applications for twelve (12) separate projects were received from two (2) urban agencies for a total of \$1,663,000. The Transportation Technical Advisory Committee has reviewed this item.

## **DISCUSSION:**

FTA Section 5310 program provides capital assistance to private non-profit corporations and, under certain circumstances, to public agencies. The program is intended to provide improve transportation services to meet the special needs of elderly persons and people with disabilities.

Program grants are made for 85 percent of the total project cost with the remaining 15 percent paid for by local match. Eligible projects include, but are not limited to, wheelchair accessible vans and buses, communications equipment, vehicle rehabilitation, and computer software and hardware.

Caltrans and Kern COG received applications from Bakersfield ARC (BARC) and New Advances for People with Disabilities (NAPD). These were evaluated as per Caltrans guidelines, with scores to be shared with applicants. Scoring was conducted via Caltrans' grant portal and will be submitted along with the approved Agency Certification.

Per Caltrans guidelines, the Regional Transportation Planning Agency (RTPA) must certify that projects align with the Regional Transportation Plan and the Coordinated Human Services Transportation Plan. Kern COG supports transit services for seniors and individuals with disabilities, and staff confirm the projects meet both plans. Kern COG has submitted the FY 2025–26 FTA Section 5310 Program of Projects (Attachment A).

**CALL FOR PROJECTS** 

### **DESCRIPTION:**

The California Transportation Commission (CTC) anticipates initiating the statewide Cycle 8 Active Transportation Program (ATP) Call for Projects at their March 19-20, 2026, meeting, with a project application due date of June 22, 2026. The Transportation Technical Advisory Committee has reviewed this item.

### **DISCUSSION:**

On August 21, 2025, CTC staff conducted a kick-off workshop to initiate and explain upcoming events for the roll-out of the 2027 Cycle 8 Active Transportation Program Call for Projects. Other announcements made regarding this roll-out including 1) the offer to provide virtual site visits with the CTC staff on Tuesdays and Thursdays, September 2025 through March 2026; and 2) online application portal, Submittable. Additional information on these items circulated as it becomes available. Please check the CTC ATP resource page for more information. We are providing the following information to reflect upcoming key timeline benchmarks that span from August 2025 all the way through June 2027 for the full cycle. Potential applicants should use the following links to ensure access to up-to-date information for the 2027 Cycle 8 ATP information:

https://dot.ca.gov/programs/local-assistance/fed-and-state-programs/active-transportation-program.

The preliminary Cycle 8 funding is anticipated to be \$550 million for four years of programming for fiscal years 2027-28, 2028-29, 2029-30, and 2030-31. CTC ATP guidelines and fund estimate establish a state funding share and MPO funding share for ATP programming capacity. In response, the Kern Council of Governments has an adopted ATP project delivery policy that defers to the original application review and ranking by the state for all original state submitted applications. Kern COG does not do a separate ATP Call for Projects to use the MPO share and therefore does not adopt its own modified guidelines or requests separate applications. The

timeline shown on the following page reflects the statewide call for projects and MPO segment of the process.

The dates below, provided during the August 21, 2025, kick-off workshop, may be subject to revision.

# **DESCRIPTION:**

Per the "Kern COG Project Delivery Policies & Procedures Chapter 2: Implementation Procedures Overview," project delivery letters are **due January 16**, **2026** for Active Transportation Program (ATP), Congestion Mitigation Air Quality (CMAQ), and Regional Surface Transportation Program (RSTP) projects. The Transportation Technical Advisory Committee has reviewed this item.

## **DISCUSSION:**

The "Kern COG Project Delivery Policies & Procedures Chapter 2: Implementation Procedures Overview" was last updated at the April 15, 2021 Kern COG Board meeting. The Kern COG Project Delivery Policy states that projects in the current fiscal year need to be submitted for funding authorization by January 31<sup>st</sup>. # **DESCRIPTION:**

Thirty-nine CMAQ applications are under review. Kern COG to provide the latest updates. The Transportation Technical Advisory Committee (TTAC) has reviewed this item.

### **DISCUSSION:**

### **Background**

Forty-two CMAQ applications were received for the 2025 CMAQ Call for Projects, requesting \$78.7 million in CMAQ funds. Three CMAQ applications were withdrawn. The CMAQ application summary and applications received were posted to the Kern COG website at <a href="http://www.kerncog.org/category/docs/ftip/">http://www.kerncog.org/category/docs/ftip/</a>. Kern COG staff has processed the submitted applications considering the following factors in the development of the proposed program:

- A. Use of Kern COG CMAQ Policy and Procedures for technical analysis;
- B. Use of Federal Highway Administration CMAQ Program Guidance for eligibility criteria;
- C. Use of Air Resources Board's methodology to calculate emission reductions and costeffectiveness;
- D. Programming all available federal funds estimated by Caltrans; and
- E. Leveraging other possible funds available from outside sources.

### **Project Analysis**

Kern COG staff has continued to work with project applicants to clarify the following concerns:

- Purpose and need issues;
- Potentially ineligible project elements;

- Emission calculation inputs and formulas;
- Cost effectiveness based on revised emission calculations; and
- Verification of cost estimates.

A summary of comments and responses was prepared to provide clarification of submitted application and/or data revision and was sent to the TTAC. The summary was discussed at the October 15<sup>th</sup> CMAQ Workshop. Agencies represented included: Arvin, Bakersfield, California City, Caltrans, Delano, Kern COG, Kern County, McFarland, Ridgecrest, Shafter, Tehachapi, and Wasco.

# **Activities Since the Workshop**

- Kern COG staff met with City of McFarland and Caltrans District 6 to discuss project eligibility of their Park and Ride application. City of McFarland has agreed to remove EV chargers from the application.
- Kern COG staff met with City of Tehachapi to discuss project eligibility and emission calculations of their shoulder paving application. City of Tehachapi has agreed to remove the bike lane from the application.
- Kern COG staff requested revised application packets from all applicants by October 29th.
- Kern COG staff met with Caltrans District 6 to discuss street classifications. Caltrans
  District 6 Local Assistance staff have been instructed by HQ that the information on the
  FTIP and LAPM 3-A must match the CRS. Please see attachments A and B.

### **Upcoming Activities/Dates**

- Kern COG staff will prepare the draft program of projects. Kern COG will circulate the draft as part of the January TTAC and TPPC meetings.
- Kern COG staff will circulate the final program of projects as part of the February TTAC and TPPC meetings.

## **CMAQ Funds for Local Road Projects**

Nine CMAQ applications with local roads were received for the 2025 CMAQ Call for Projects, totaling \$16.5 million in CMAQ funds. Two applications were withdrawn, and one was revised to exclude portions with local roads. After coordination with Caltrans District 6, local roads are eligible under CMAQ/CRP. However, under Chapter 5 of Kern COG Project Delivery Policies and Procedures local roads are not CMAQ/CRP eligible; "road projects must have a functional classification of urban collector, or major rural collectors or higher." At the March 2025 TTAC and TPPC the CMAQ Timeline and Funding Targets were approved which allowed Kern COG staff to move forward with programming the CRP funding following the CMAQ Policy and Procedure project selection process. Kern COG staff recommends following Kern COG Project Delivery Policies and Procedures which exclude local road projects.

On November 5<sup>th</sup>, the TTAC recommended adding local road projects to the contingency list, with the condition that applicants may only request funding authorization once all eligibility requirements are met.

The TTAC also recommended considering the City of Wasco's project as a non-local road project in this CMAQ Call for Projects since the City of Wasco has started the process of updating the Caltrans CRS Functional Classification Map.

<u>ACTION</u>: Add local road projects to the CMAQ Call for Projects contingency list, with the condition that applicants may only request funding authorization once all eligibility requirements are met. Also consider the City of Wasco's project as a non-local road project in this CMAQ Call for Projects. – ROLL CALL VOTE

- A. Marked-up CRS map showing desired changes
- B. Functional Classification Change Request form (in Excel format)
- C. City/County resolution
  - If the request matches the General Plan Circulation Element, submit the resolution that approved the General Plan and attach the Circulation Element.
  - However, if the request does not match the General Plan, submit a new resolution (see example on page 4).
- D. MPO/RTPA concurrence letter





Step 2. The Caltrans district coordinator reviews and writes a district concurrence letter.





Step 3. Caltrans headquarters presents the proposed changes to FHWA for approval.





Step 4. The approved CRS maps are posted on the internet.




# Marked-up Map (option 2)



MOBILITY INNOVATIONS AND INCENTIVES PROGRAM - STATUS REPORT

### **DESCRIPTION:**

To help meet more stringent air standards, Kern COG promotes early deployment of alternative fuel vehicle technologies such as plug-in electric vehicles (EVs) and compressed natural gasfueled vehicles. This report covers the period July 1, 2025, to September 30, 2025. The Transportation Technical Advisory Committee has reviewed this item.

# **DISCUSSION:**

**Kern EV Charging Spaces:** Please find the most recent charging space inventory by zip code attached to this staff report. The report shows that as of September 30, 2025, there is a 279.20% increase in charging spaces (1,181 spaces) throughout Kern County over the July 2016 base month and year, when Kern COG began tracking electric vehicle charging spaces. Six new locations have been identified in this reporting period, adding 131 charging spaces.

### **EV Ready Communities:**

- Kern COG Staff completed written reports to the CEC and participated in monthly calls with the CEC Contract Agreement Manager.
- EV Charging Stations in ten locations throughout Kern County: Five sites have completed
  installation. The sites include City of Arvin, California City, McFarland, City of Taft, and
  Wasco. Ribbon-cutting celebrations will be rolled out as stations open. During this period,
  delays in electrical installations, parts, permits, and location site readiness have served to
  delay several of the site openings. Kern COG is working with all the station hosts to
  complete deliverables by December 2025.
- Workforce Development: Kern Community College District reports a second EV Training class started March 13, 2024, at Bakersfield College. They are researching a more robust TESLA program and are currently in negotiations. Kern Community College District reports that a replacement off-grid charging station has been received from the vendor.

 Kern EVCS Blueprint Update: The EV Ready Communities funding is being used to implement the 2024 EVCS Blueprint. A five-year update to the Blueprint is scheduled to be completed in 2026. DKS Associates held a stakeholder meeting on September 16, 2025, to provide an update on future EV infrastructure demand forecasts, siting analysis criteria, and current gap analysis. The last stakeholder meeting will be held November 6, 2025.

**Fast Charge California Project -** The California Energy Commission is accepting applications for its Fast Charge California Project Program, which provides incentives for purchasing and installing eligible direct current (DC) fast chargers. To be considered for a rebate, applications must have a minimum of 50% CCS connectors installed for incentive funding. There is an extension for applications till January 29, 2026. # Kern County Electric Vehicle Public Charging Spaces by Zip Code

# November 2025 Report

Kern Council of Governments has set a goal of 4,000 electric vehicle charging spaces in Kern County by 2025. This report shows a 279.20% increase (1,181) in the number of charging spaces compared to the baseline inventory established July 2016. This represents an increase of 131 spaces (8.89%) over the July 2025 report of 1,473 spaces. Highlighted numbers reflect updates from the previous report. Some of this change in inventory may simply be due to better reporting and not new chargers or disconnections. This change in inventory may also include station closings.

The number of parking spaces and station status are validated by telephone and occasionally in person. The primary resource for identifying stations is the Alternate Fuel Data Center (AFDC) Station Locator (<a href="www.afdc.energy.gov/locator/stations">www.afdc.energy.gov/locator/stations</a>). The AFDC data was downloaded on October 1, 2025. Plugshare.com and charging station networks are also used to update the inventory. Not all sites list their locations on these websites. Level 1, Level 2, DC Fast Charging, Tesla Superchargers and wall plugs are counted. Note that some chargers may serve more than one parking space. These reports charging spaces, not the charging stations. This follows along with the expression to move cords, not cars. Public transit charging is not counted in this inventory.
